- The second year before your arrival in Québec if your date of arrival was between 1 January and 30 June.

Indicate only the earnings outside Canada that have not been declared and will not be declared to Revenu Québec. You must also provide your spouse's earnings outside Canada, even if he or she does not live in Canada.

The information about earnings declared to Revenu Québec or that will be declared to Revenu Québec will be transferred to us directly by that agency. Do not indicate them on this form.

If you or your spouse was living in another Canadian province on 31 December of one of the years for which we require information, you must provide a copy of your Notice of Assessment from Revenue Canada for that year. Do not indicate those earnings on this form.
