To sign up for or make a change in direct deposit

To sign up for or make a change in direct deposit, you must:

- Fill in Section **A** of the authorization;
- Have Section **B** filled in by an authorized person at your financial institution or post office;
- Enclose a statement of bank account information or of postal account information, or a blank cheque with “VOID” written across it;
- Return the documents to us at the address shown below:

Note: If you are making a change of account, you must wait until you have received a first payment in your new account before closing the old one.

Some good reasons to sign up for direct deposit

The Régie des rentes du Québec offers you the possibility of receiving your pension by direct deposit in the currency of your country of residence, in your bank account or postal account at the institution of your choice.

Direct deposit is:

- **Simple**
You receive your pension directly in your account.
- **Fast**
There are no postal or cashing delays.
- **Economical**
You won't have to pay cashing fees.
- **Safe**
You will always receive your pension on time even if there is a postal strike.
- **Flexible**
If you change your mind, you can always ask to receive your payments by mail, in Canadian funds.

More than 91% of the beneficiaries of the Québec Pension Plan receive their pensions by direct deposit.
