The limit to the costs for producing the statement of benefits that a member and his spouse are entitled to obtain in the cases mentioned in sections 108 and 110 of the Supplemental Pension Plans Act (R.S.Q., c. R-15.1) and the limit to the expenses incurred for effecting a transfer of benefits between spouses are fixed as follows:

Act	Pension plan	Limit
(1) for the issuance of a statement of benefits	defined contribution plan	\$150
	combination plan	\$325
	any other plan	\$250
(2) (<i>Repealed</i>)		
(3) for effecting the transfer of benefits	defined contribution plan	\$100
	combination plan	\$200
	any other plan	\$150
