International Fuel Tax Agreement

IFTA

If you are based in Québec and operate one or more **qualified motor vehicles in two or more jurisdictions**, you must complete this form to obtain a licence and decals, in accordance with the provisions of the International Fuel Tax Agreement (IFTA). A "qualified motor vehicle" is any vehicle, other than a vehicle used by a person exclusively for recreational purposes (i.e., not in connection with any business endeavour), that is used, designed, or maintained for the transportation of persons or property and

- has three or more axles;
- has two axles and a registered gross weight of more than 11,797 kilograms (26,000 pounds); or
- has two or more axles and is used in combination with another vehicle, resulting in a total weight of more than 11,797 kilograms (26,000 pounds).
