**Note:** The Minister of Revenue will not grant registered museum status to an organization that is already registered as a charity or a cultural or communications organization or has already been recognized as an arts organization. Furthermore, the organization must show that it has been recognized as a museum by the Minister of Culture and Communications and that this recognition is still effective.
