¹ These figures include only a subset of those receiving Income AssistanceINCLUDED are those on Temporary Assistance. **EXCLUDED** are those on Continuous Assistance (Disabled or with persistant multiple barriers to employment), Children in the Home of a Relative, and OAS/Seniors. A recipient is defined in these reports a**each person living in a family or living alone that is receiving basic Income Assistance'.** Data do not include aboriginal people living on reserve. Since 2002, the program is BC Employment and Assistance but the definition used is identical to previously published material.

² Beginning in June 1997, the combined IA+EI rate in this report has been adjusted to count only once those persons receiving both Employment Insurance and Income Assistance. Therefore use caution when comparing current data to pre June 1997 data. This adjustment resulted in an overall decrease of 0.3 percentage points to the BC rate in June 1997.
