


Issue 23: The Self Employed

- In 1991, 193,665 workers in British Columbia (11 per cent of the experienced labour force) were either self-employed in an unincorporated business or owner-operators of an incorporated business.
- Men were twice as likely as women to be self-employed.¹ In 1991, one in seven men in the labour force was self-employed, compared to one in every fourteen women.
- As the graph below illustrates, the number of self-employed females increased by 49 per cent between 1986 and 1991. This was twice the growth rate of the total female labour force and about three times the increase in male self employment over the same period.

Female self employment increased almost three times as fast as male self employment between 1986 and 1991



- In 1971, one in six unincorporated self-employed workers was female; by 1991, the share had doubled to one in three.
- Self-employed operators of unincorporated businesses were most likely to work alone or with unpaid family help. In 1991, seven in ten self-employed females and six in ten self-employed males who operated unincorporated businesses did not have any paid help.
- In contrast, seventy per cent of self-employed workers in corporations had paid employees in 1991.

- The share of unpaid family workers² in the labour force has declined from about 2.6 per cent to 0.3 per cent during the last twenty years.
- The majority of unpaid family workers were female. In 1971, females made up 81 per cent of unpaid family workers; by 1991, the share had fallen slightly to 74 per cent.
