#### **WEEKLY INCIDENT REPORT 20 Mar to 26 Mar 2006**

#### **FERRY SINKING**

On 22 Mar 06 the BC Ferry Queen of the North ran aground while traveling from Prince Rupert to Port Hardy. The vessel sank carrying 16 passenger vehicles and was almost fully loaded with 225,000 litres diesel fuel, 15,000 litres of light oil, 3,200 litres of hydraulic fluid and 3,200 litres of stern tube oil. The incident was raised to urgent status (Code 2) by the Ministry of Environment (MOE) Response Officer due to the volume of the spill and potential impact to the environment. Passengers and crew abandoned ship. 99 of the 101 people on board were accounted for. Officials continue efforts to locate the missing couple believed to have been on board the vessel. Rescued passengers were initially transported to the community of Hartley Bay and were later transferred to Prince Rupert by Coast Guard.

Ministry of Environment (MOE) and BC Ferries activated an Incident Command Post (ICP) under unified command in Prince Rupert with the participation of Environment Canada, Dept. of Fisheries and Oceans, Indian and Northern Affairs Canada, local First Nations Representatives, Burrard Clean and the Canadian Wildlife Service.

BC Ferries with the assistance of the Emergency Program Coordinator and the Emergency Social Services team in Prince Rupert, made arrangements for accommodations, meals and incidentals for the evacuated passengers. Members of a Critical Incident Stress Debriefing team provided counselling to the passengers and crew. The Insurance Corporation of British Columbia staff were deployed to expedite the replacement of vehicles that were lost with the ship. BC Ferries committed to restoration of service to the region and addressing any short term transportation/supply disruptions.

There are no public safety impacts from the spill at this time. At least two over flights per day and boat reconnaissance are planned to monitor the slick. Booms are in place and no impacts to wildlife have been reported at this time. Shoreline cleanup Assessment Teams are conducting training including First Nations. The NWE Regional PREOC and the PECC were activated to level one to provide support at the onset of the incident and were stood down on 25 March 2006.

#### **FLOOD**

On 24 Mar 06 an assessment of private property near McLeese Lake in the Williams Lake area was conducted to ensure that there was no risk of public impact or public safety issues as a result of flooding. Staff from MOE, Ministry of Transportation and the Regional District of Cariboo conducted the site assessment. It was determined that no government assistance was required at this time and the property owner was provided some mitigation and protective works advice.
