INSTRUCTIONS

Please type or print clearly in block letters and ensure that the form is signed and dated in ink.

- Item A** This is the registration number assigned by the registrar of companies at the time the limited liability partnership was registered.
- Item B** Enter the registered business name of the limited liability partnership.
- Item C** This is the date the partnership was registered as a limited liability partnership in BC.
- Item D** This is the anniversary date of registration. A limited liability partnership must annually, within two months after each anniversary of the date on which the partnership was registered as a limited liability partnership, file an annual report with the registrar. **Failure to file** an annual report for two consecutive years may result in the registrar of companies taking action to cancel the registration of the limited liability partnership.
- Item E** Section 111 of the *Partnership Act* requires a limited liability partnership to promptly notify the registrar of companies of any changes to the information included in the registration statement. Go to our Web site at www.fin.gov.bc.ca/registries to download the **Form 3, Changes to Registration Statement**.
- Item F** This is the name and signature of the authorized signing authority for the limited liability partnership. If the authorized signing authority is a corporation or firm, this form must be signed by an authorized signing authority for that corporation or firm.

Submit this form with a cheque or money order made payable to the Minister of Finance, or provide the registry with authorization to debit the fee from your BC OnLine Deposit Account. Please pay in Canadian dollars or the equivalent in US funds.
