 - Item F** This is the name and signature of the authorized signing authority for the extraprovincial limited liability partnership. If the authorized signing authority is a corporation or firm, this form must be signed by an authorized signing authority for that corporation or firm.
- Filing Fee: \$30.00** Submit this form in duplicate with a cheque or money order made payable to the Minister of Finance, or provide the registry with authorization to debit the fee from your BC OnLine Deposit Account. Please pay in Canadian dollars or the equivalent in US funds.
