Chicken Industry Opportunities in BC New Grower Information Package

INDUSTRY PROFILE

The B.C. chicken industry is comprised of several sectors cooperating to produce chicken and further processed chicken products for the consumers of B.C. The organization of the B.C. chicken industry showing the number of production units, the capital investment of each sector and the volume and value of products is shown on page 3.

"Broiler Breeder Hatching Egg Producers" produce hatching eggs that are sold to "Hatcheries" where they are incubated to produce commercial chicks. The hatcheries sell the chicks to the "Chicken Growers", who rear them and sell the market weight birds to "Primary Processing Plants" for evisceration. The whole bodied birds are upgraded to value added products in "Further Processing" operations. The "Processors" sell the whole bodied birds and further processed products to "Brokers", "Hotels, Restaurants, Institutions (HRI)", and "Retailers" who in turn sell to "Consumers".

Most hatcheries in B.C. are vertically integrated into processing operations, processing chicken derived from chicks from their own hatcheries. The "Feed Industry" and equipment suppliers are largely independently owned and operated.

The major inputs to broiler hatching egg production are feed, chicks, and labor. The major inputs to the chicken grower are feed and chicks.

There were 68 broiler hatching egg producers in B.C. in 1995. B.C.'s broiler hatching egg production has increased 8% compounded annually from 39.9 million hatching eggs in 1984 to 91.5 million eggs in 1995, valued at \$26.3 million. The balance of hatching eggs required by hatcheries are imported. The volume imported depends upon the price differential between B.C. and U.S. hatching eggs, and has varied historically from a net export of 300,000 eggs/yr in 1985 to a net import of 10 million eggs/yr in 1993.

There were 308 chicken growers in B.C. in 1995, with approximately 80% of the growers and volume in the Lower Mainland, 11% on Vancouver Island, and 9% in the Interior. B.C.'s chicken production has increased 8% compounded annually from 57 million kg live wt. in 1984 to 138 million kg in 1995. In 1995, B.C. chicken production was valued at \$154 million at the farmgate.

OUTLOOK

The outlook for the B.C. chicken industry is for lower growth, narrower profit margins, more variable feed costs and more intense product competition from other provinces and countries.

With the implementation of GATT/NAFTA, the B.C. chicken industry moved from a system of "supply management" based on quantitative border controls to a system of "orderly marketing" which requires enhanced responsiveness to market forces. GATT/NAFTA Agreements converted quantitative border controls on chicken and hatching egg imports to tariffs that are to decline over time. The loss of tariff protection would result in intense competition from the U.S., leading to more vertical integration in the B.C. poultry industry, and reduced profit margins and quota values for hatching egg producers and chicken growers.

The B.C. broiler hatchery egg producer share of the B.C. market is expected to decline as hatcheries import more eggs from the U.S. as tariffs decline.

B.C. chicken production is expected to show 0-2% growth in 1996 followed by approximately 3-5% growth thereafter, depending upon the degree of participation by B.C. growers in the export markets. Growth in B.C. chicken production will be more dependent upon growth in the export markets than in the past.

QUOTA/MARKETING BOARDS

B.C. broiler hatching egg producers require production quota. Broiler hatching egg quota is administered by the B.C. Broiler Hatching Egg Commission. The B.C. Broiler Hatching Egg Commission operates under a national agency called the Canadian Broiler Hatching Egg Marketing Agency.

B.C. chicken growers operate under a quota system administered by the B.C. Chicken Marketing Board (BCCMB). The BCCMB has authority over the marketing of chicken in the province. The BCCMB works cooperatively with the Canadian Chicken Marketing Agency, the national supply control agency for chicken. The BCCMB and the Broiler Hatching Egg Commission operate under the supervision of the British Columbia Marketing Board, a provincial government appointed board which hears appeals, and monitors all marketing boards in the province.

NICHE MARKETS

There are approximately 12 growers producing "specialty chicken" and one producing "organic chicken". Specialty chicken is grown without antibiotics. Organic chicken is grown according to the Certified Organic of British Columbia Guidelines, which were established under the Food Choice and Disclosure Act. The Chicken Marketing Board reviews applications to produce niche market chicken and issues production permits accordingly.


