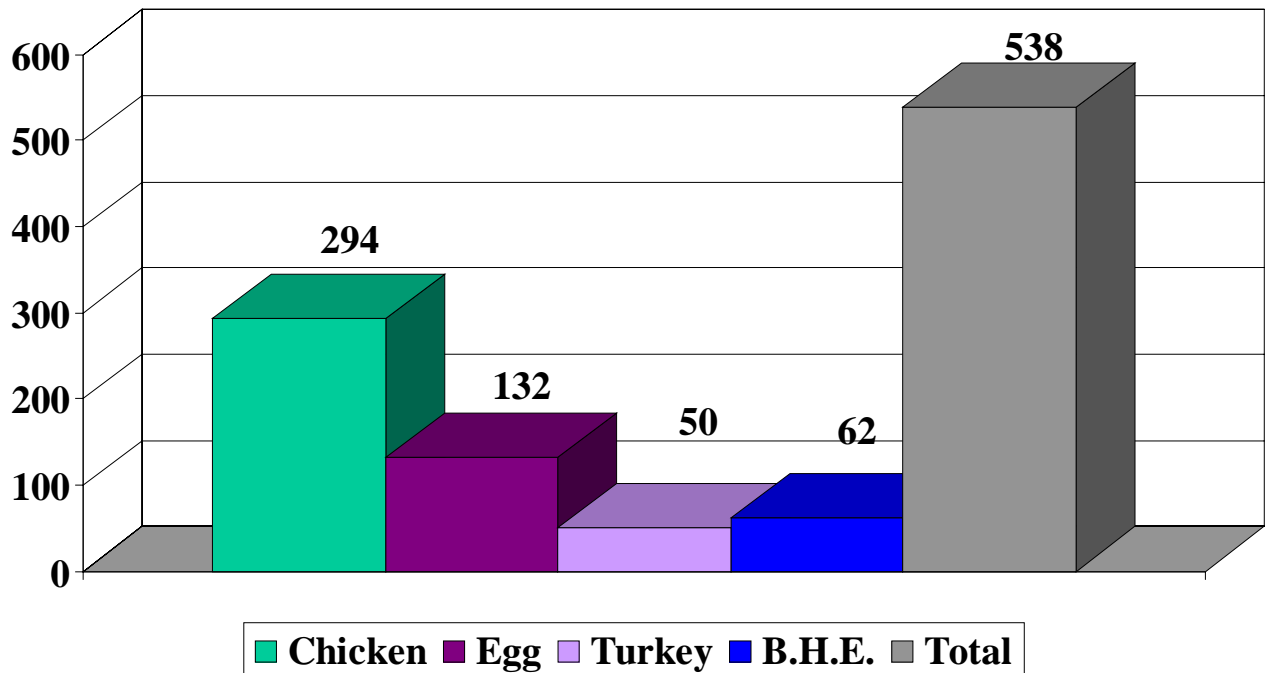

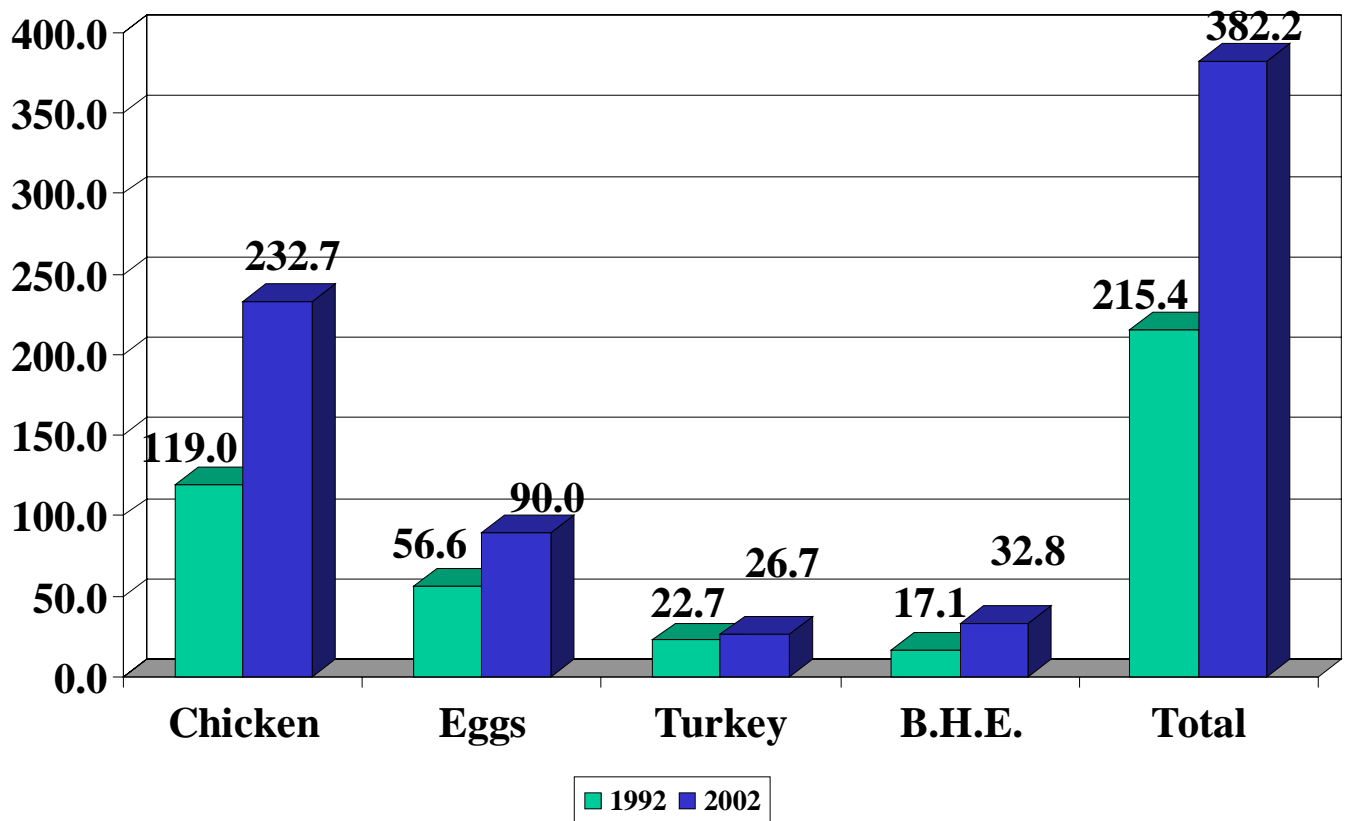

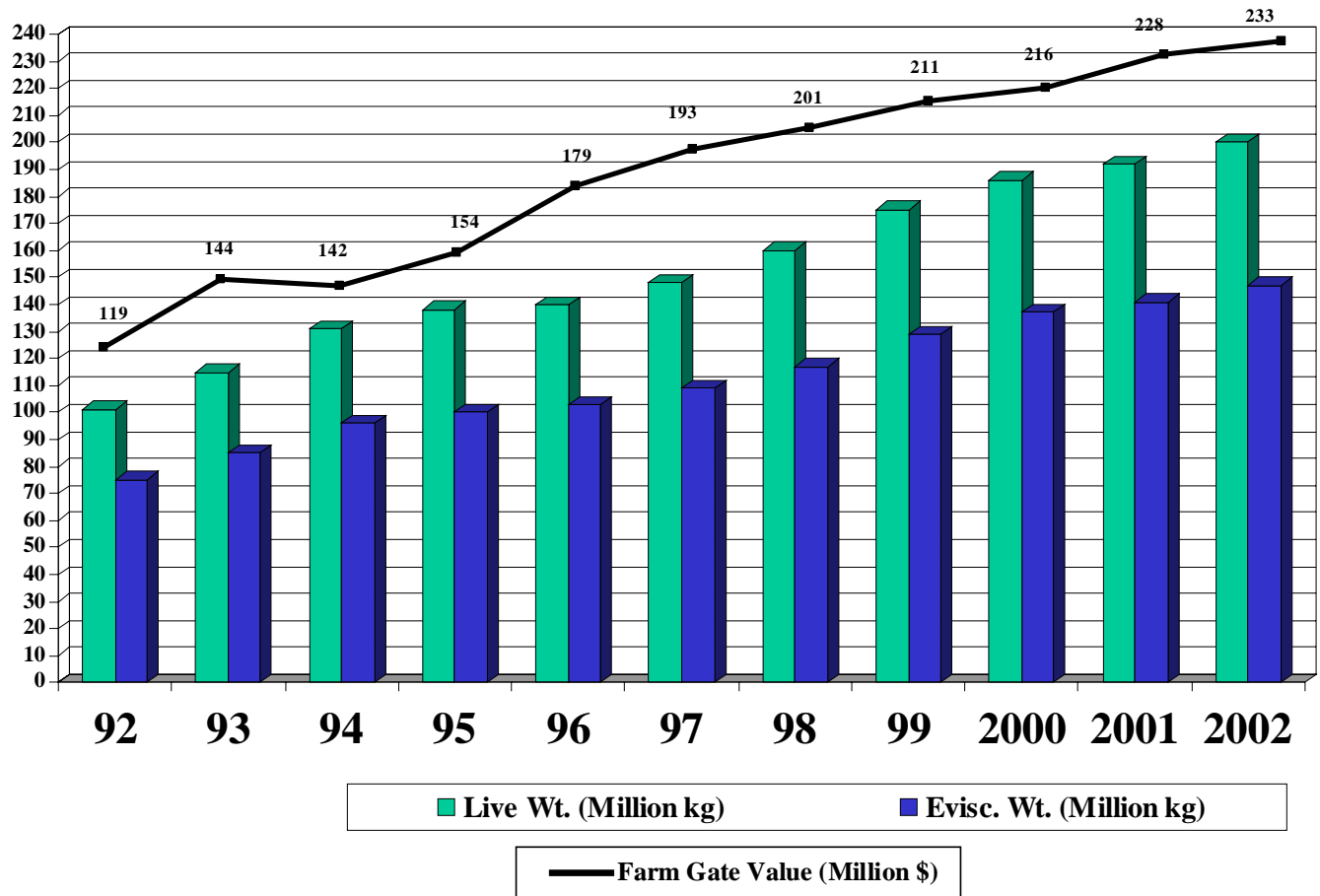

BC Chicken Production and Value 1992 – 2002



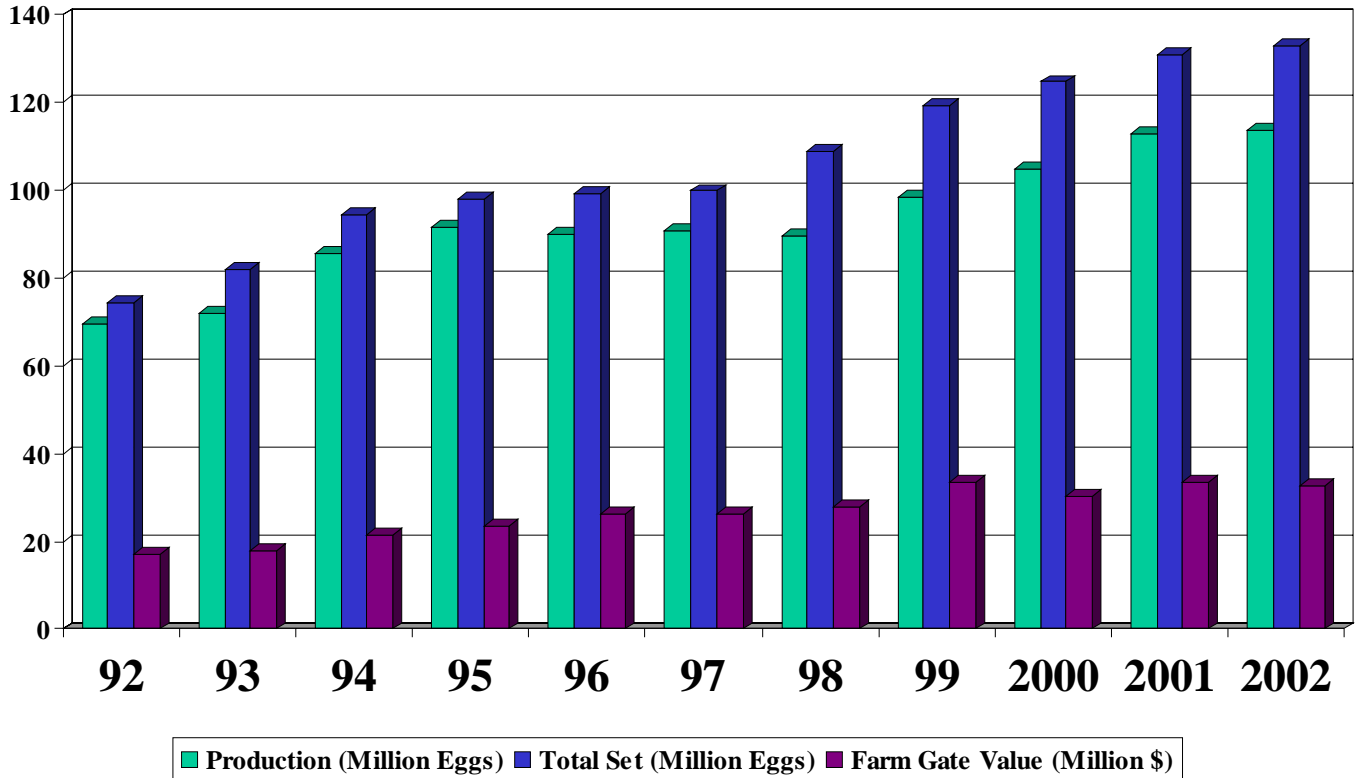

BC Broiler Hatching Eggs Production and Value (1992 - 2002)



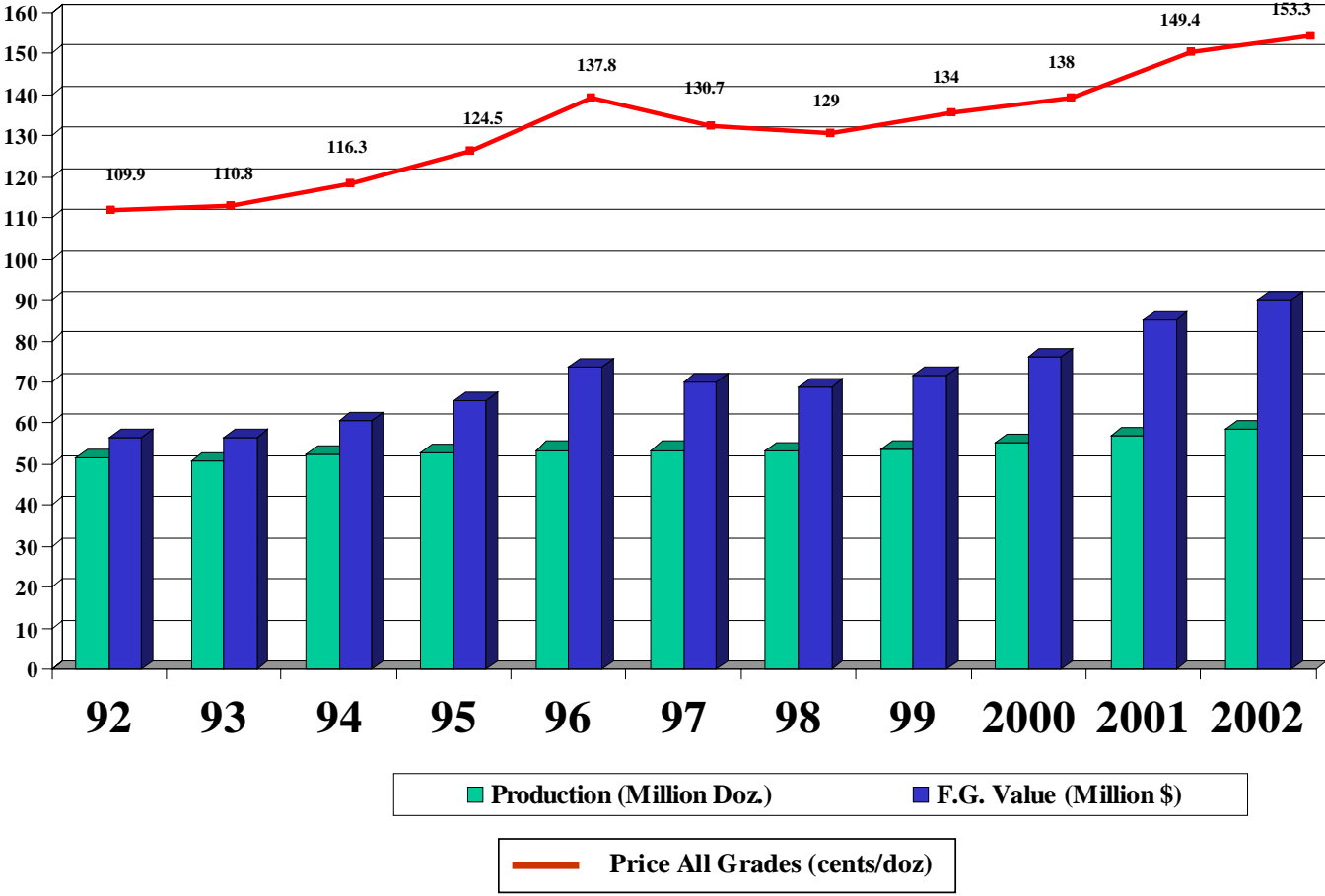
