### How to Obtain Information on Contaminated Sites

#### Updates on new items and activities

We offer a free e-mail service to provide up-todate news on contaminated sites developments. The CS e-Link is a free e-mail list service that notifies subscribers when and where to find information, online documents, news, and announcements related to contaminated sites and the contaminated sites system. Consult the contaminated sites home page under "CS e-link" to subscribe to this service.

#### Information on specific sites in BC

To find information about a particular site, search the ministry's Site Registry through BC OnLine (www.bconline.gov.bc.ca). Fact Sheets 20, 23, and 24 provide further details (follow the links from the Contaminated Sites Program home page). The *Site Registry User's Guide* is also available on BC OnLine's web site. As well, if you request it, we will perform a search for you.

If you wish to obtain site information that is available in paper records or on other databases, we can also get that for you. Submit a request to us by filling out the Site Information Request form (available on our web site).

## Others sources of information on contaminated sites in BC

The Ministry of Environment plays a regulatory role in the assessment, clean-up and management of contaminated sites broadly in BC. But it is not the only agency with responsibility for contaminated sites.

The Crown Contaminated Sites Program of the Ministry of Agriculture and Lands manages contaminated sites located on provincial Crown land in BC.
