# Resources to Ensure Strong Municipal Services

Local governments are the front-line providers of the community services that British Columbians depend on. That's why the government has protected funding for local government grants, to ensure strong municipal services. The province has:

- Commited \$122 million towards policing, corrections, and crime prevention.
- Provided over \$130 million per year in grants to local governments, to help them build safe, healthy communities.
- Maintained unconditional grants to ensure local governments have the flexibility to allocate resources where they are needed most.
- Partnered with federal and local governments to fund more than 250 infrastructure improvement projects.

# **Strengthening Local Decision-Making**

We've provided municipalities with a modern legislative framework through the new Community Charter, which increases local autonomy and accountability, and harmonizes provincial and local government relations. The charter:


- Empowers local governments to make the best decisions for their areas.
- Enables local governments to streamline and standardize regulations across municipal boundaries, making it easier for businesses to operate in multiple jurisdictions.
- Outlaws downloading of costs by the province.
- Enhances local accountability by ensuring councils prepare annual reports.

# Improving Transportation to Create Jobs

Increasing the safety, efficiency and integration of our transportation network will open up new economic opportunities. The province has:

- Budgeted over \$2 billion for transportation infrastructure over the next three years.
- Renewed the Canada-B.C. partnership that has so far dedicated \$336 million to upgrade the Trans-Canada Highway and other trade corridors.
- Committed to address an array of safety, congestion and capacity concerns across B.C.
- Adopted a new approach for BC Ferries that will improve service, guarantee service levels and fair rates and see \$2 billion in fleet and asset renewal.
- Embarked on a new partnership for BC Rail, based on input from northern communities, to improve access to external markets.

# Protecting Public Health Through Safe Drinking Water

The province has created a drinking water action plan to ensure source-to-tap protection, and has:

- Created the Community Water Improvement Program providing \$80 million towards drinking water and waste water management projects with a total value of \$120 million.
- Funded, with federal and local partners, 100 waterrelated improvement projects valued at over \$332 million.
- Added \$1.5 million in funding for drinking-water monitoring and protection.
- Passed new drinking-water and groundwater legislation to enhance testing and assessments and provide for new drinking-water officers.

### Stronger Measures to Improve Public Safety

To ensure safer streets and communities, the province has:

- Returned 100 per cent of all net traffic fines to municipalities, exceeding the New Era commitment of 75 per cent. This funding, over \$40 million/year, is part of a comprehensive strategy to enhance community policing, crime prevention and public safety.
- Passed new laws to crack down on street racing and strengthened penalties for drunk driving.
- Legislated greater parental responsibility for property crimes committed by children.
- Protected funding for transition houses for women and children, as well as individual and group counselling.
- Improved services for victims of crime by funding 24 new police and community-based programs across B.C., plus a 24-hour crisis line for victims who need help.

### **Strengthening Local Economies**

We've launched the Heartlands Economic Strategy to create action plans with local and regional governments, businesses and First Nations and unleash the potential of all B.C. communities. Key commitments include:

- Establishing a B.C. Resort Task Force to expedite growth and expansion in B.C.'s resort sector.
- Introducing the Forestry Revitalization Plan, which will see the province work with forest companies, communities, workers and First Nations to ensure a competitive, sustainable forest industry.
- Creating the Rocks to Riches Mineral Development Strategy, to double annual investment in exploration, support mine discovery and generate exploration and mining jobs.
- Developing an energy plan that will work toward government's goal of stimulating new energy investment and creating thousands of new jobs.
- Generating regional economic development plans that focus and build on regional strengths.
