Occupations listed in the B.C.-Alberta Agreement on Trade, Investment and Labour Mobility

The agreement enhances labour mobility by recognizing occupational certifications of workers in both provinces. It applies to all occupations for which there are provincial regulations – no exceptions. The provinces have identified the following occupations for which regulations will be reconciled during the transitional period April 1, 2007 to April 2009.
