

## **Inventory of Breeding Herd Animals**

Producers must complete the inventory registration forms to be eligible for payments under the Canada British Columbia Cull Animal Program. There are two components to the program:

- 1. Provincially funded per head payments based on a percentage of your registered breeding herd on September 1, 2003. This payment is initiated once the administration receives your inventory registration forms. Sales or slaughter documentation are not required.
- 2. Federally funded payments based on culled animals that are sold for slaughter from September 1, 2003 to December 31, 2004. Documentation of sale for slaughter will be required.

Random inspections will be made to verify reported breeding herd inventories.

For more details refer to the attached Canada British Columbia Program and Registration Conditions.

## **Instructions:**

- 1. The registration consists of three parts the Applicant Information, the Breeding Herd Inventory forms and the Program Conditions.
- 2. The registration must be submitted in the name of the owner(s) of the breeding animals as of September 1, 2003. Registrations submitted in the name of a dealer or agent acting on behalf of the owner(s) will not be accepted.
- 3. A separate breeding herd inventory form must be submitted for each type of animal (Beef, Dairy, Sheep/Goats, Cervids) DO NOT include animals that were on a backgrounder program or in a feedlot on September 1, 2003. The program is for breeding herds only. DO NOT include bred females that have not birthed.
- 4. Additional documentation may be requested from applicants to aid in the verification of eligibility.
- 5. All applicants are required to submit their Business Number or Social Insurance Number to allow for issuance of AGR-1 tax slips.







## **Program and Registration Conditions**

The Canada British Columbia Cull Animal Program consists of two components:

- 1. Provincially funded per head payments based on a percentage of your registered Breeding Herd on September 1, 2003. Sales or slaughter documentation are not required.
- 2. Federally funded payments based on culled animals from your registered Breeding Herd that are sold for slaughter from September 1, 2003 to December 31, 2004. Documentation of sale for slaughter is required.

These **Program and Registration Conditions** describe program conditions for the British Columbia component only. Registration conditions are the same for the provincial and federal components. Program conditions for the federal component will be available at a later date.

## 1.0 Purpose:

The objective of the registration is to establish the inventory of Breeding Herd animals in order to determine the basis of payment for the provincial component and to allow both levels of government to forecast costs.

## 2.0 Definitions:

- **2.1 Breeding Herd:** A herd of Eligible Animals maintained for the primary production goal of producing, raising and weaning offspring.
- **2.2** Eligible Animals: Beef and dairy cattle, sheep, goat, bison and cervid animals that are the required age (see 3.2.1), or have produced an offspring, as of September 1, 2003 and are owned by the Registrant on September 1, 2003.
- **2.3** Eligible Cull Animals: For purposes of this program, the Eligible Cull Animals will be 8% of the registered Eligible Animals for beef and bison, 16% of the registered Eligible Animals for dairy and 12% of the registered Eligible Animals for sheep, goats and cervids.
- **2.4 Minister**: The Minister of British Columbia Agriculture, Food and Fisheries and his authorized representative(s), including but not limited to a representative of the Minister of Agriculture and Agri-Food Canada.
- **2.5 Registrant**: The person(s) signing the Canada British Columbia Cull Animal Program Inventory Registration Form.
- **2.6 Registration Form**: The Canada British Columbia Cull Animal Program Inventory Registration Form including the Applicant Information and the Program and Registration Conditions.
- 2.7 **Registration Process**: The administrative process of compiling Registration Forms from Registrants from the date of the announcement of the Canada British Columbia Cull Animal Program to January 31, 2004 unless otherwise modified pursuant to section 8.

## 3.0 Eligibility:

## 3.1 Eligible Registrants:

- 3.1.1 An Eligible Registrant is one who:
  - a. held title as of September 1, 2003, to the Eligible Animals listed;
  - b. under the *Income Tax Act* (Canada) or the *British Columbia Company Act*, would be liable to pay British Columbia income tax or corporate tax or claim losses on income from the production of Eligible Animals.
  - 3.1.2 Any of the following that meet the specifications of 3.1.1 and 3.1.3 may apply: individuals, proprietorships, corporations, not-for-profit corporations, registered or non-registered partnerships, members of Indian Bands, and Métis settlements.
  - 3.1.3 Where an owner of Eligible Animals has a lease agreement for feeding, boarding etc., the Registration must be made in the name of the cattle owner. The Registrant must disclose the name of the other producer involved with the care of these animals.
  - 3.1.4 Research stations, universities and other government-funded organizations are not eligible.





## 3.2 Eligible Animals:

3.2.1 Eligible ruminants are beef and dairy cattle, bison, sheep, goats and cervids. Animals must be part of the Breeding Herd and have produced an offspring or meet minimum age requirements. The minimum age requirements are 30 months for beef and dairy cattle, 36 months for bison, 12 months for sheep and goats, 30 months for cervids.

## 4.0 Registrations:

- 4.1 Registrants are required to submit a completed Registration Form to the program administration.
- 4.2 Eligible Registrants as provided for in 3.1 must make the registration.
- 4.3 Registrations must be postmarked or faxed no later than midnight January 31, 2004.

### 5.0 Signatures:

- 5.1 Designates are not permitted to sign the registrations unless they have duly authorized powers of attorney, proof of which must be submitted with the application.
- 5.2 Registrations must be signed by, or on behalf of, a properly authorized person. The Minister may require evidence of authorization. If two or more individuals are listed on the same form, only a properly authorized person is allowed to sign on behalf of Registrant.
- 5.3 The registration is not deemed complete unless the Statement of Certification on the Inventory Registration Form is signed.

### 6.0 Verification:


- 6.1 The Registrant(s) consent to the Minister releasing any information contained in the registration or related to it and obtained by the Minister in the course of verifying or auditing the registration to any other government department, agency or other body for the purposes of verifying this registration, determining the Registrant's eligibility for other related programs, or both. The Registrant(s) expressly authorize the Minister to obtain information from any government department, agency or other body to verify the contents of this registration and to determine the applicant's eligibility for other programs offering financial assistance for which the Registrant is eligible.
- 6.2 Registrants agree to give representatives of the Minister access to examine their farming or business operation. Registrants agree to make available to the Minister all farm records, books of account, and income tax returns necessary to audit the operation or to verify any information provided in their registration.
- 6.3 The Minister may require a Registrant to provide copies of all farm records, books of account, and income tax returns of persons who are involved in non-arm's length and partners and shareholders or members who actively farm on behalf of the Registrant, necessary as the Minister's discretion to verify or audit the registration. If the Registrant fails to provide the records within a reasonable time on reasonable notice, the Registrant may be ineligible for future programs.
- 6.4 The Registrant agrees to provide further information related to the Eligible Animals that the province may reasonably require for the purpose of administering the Registration Process. The Registrant also authorizes the release of any information to the Minister relating to the Registrant's farming or business operation from/to any government department, agency or corporation, for the purpose of verifying information under this registration or other provincial or federal programs.

## 7.0 **Program Payments for the Provincial Component:**

Eligible Registrants will receive a per head payment on their Eligible Cull Animals of \$128 for beef, bison and dairy animals, \$25.60 for sheep and goat animals and \$32 for cervid animals.

## 8.0 Termination of the Registration Process:

- The Minister may terminate this Registration Process any time without notice to potential Registrants if:
  - (a) the Minister determines, at his discretion, that the Registration Process shall not continue;
  - (b) the date of January 31, 2004 has passed.





### 9.0 False or Misleading Information:

Registrants who provide false or misleading information under this Registration Form forgo all rights to any benefit for which the Registrant as a result of this registration would otherwise be eligible for from future programs.

### **10.0** Ministerial Discretion:

The Minister has the absolute discretion to determine the acceptance of any registration under this Registration Process notwithstanding the Program and Registration Conditions.

#### 11.0 No Liability

The Registrant acknowledges that Her Majesty the Queen in right in British Columbia is not liable to the Registrant, the Registrant's heirs, administrators and assigns for the personal injury, property damage, or any other damage, injury, claim or loss whatsoever arising out of this registration and the Registrant's participation in it.

#### 12.0 Representations and warranties

- 12.1 The Registrant represents and warrants that the person signing is duly authorized to make this registration, bind the Registrant, and, in the case of a partnership, bind the partners to this agreement on the basis of joint and several liability.
- 12.2 The Registrant represents that no registration has been made for the same Eligible Animals by any other person, including without limitation, a person who is not 'arm's length' or a 'related person' as defined by the *Income Tax Act* (Canada), or by a shareholder, member or partner who is actively carrying on farming.

## **13.0** Changes to the Registration Conditions

The Minister may make changes to these Program and Registration Conditions from time to time. Changes to Registration Conditions ("Revised Conditions") will be effective when posted on the Minister's website at www.agf.gov.bc.ca. Registrations received after the Revised Conditions are posted will be administered according to the Revised Conditions applicable as of the date the Registrations are received.
