



AMENDMENT NO. 1 TO PESTICIDE USE PERMIT NO. 776-001-2003/2004

Pesticide Use Permit No. 776-001-2003/2004 is amended following the letter of request received by this office on June 9, 2004, according to the conditions listed below. Information bulletins describing the substance of the permit as amended shall be sent to news outlets in British Columbia using the government news release system. Information in the bulletins shall include: permit number; permit holder and contact information; purpose of use; summary of the permit amendments; how to obtain a copy of the permit and amendment or to view the permit and amendment on the government Website.

- Ac 1. Appendix A of the original application is replaced with the Revised Appendix A List of Registered Pest Control Products including the addition of Altosid XR Briquets (PCP Act registration no. 27694) and the deletion of AgroEvo SPP 1382 (PCP Act Registration no. 15187).
- Ac 2. Appendix B of the original application is replaced with the Revised Appendix B Response Levels to Trigger Pesticide Application which is based on the 2004 version of the Arbovirus Surveillance and Response Guidelines for British Columbia developed by the BC Centre for Disease Control. The revised response levels will allow (a) the pre-emptive application of larvicides to control mosquitoes prior to the arrival of West Nile Virus in a jurisdiction, and (b) the application of adulticides prior to laboratory confirmed human cases, but only after West Nile Virus has been detected in birds, mosquitoes or other mammals.
- Ac 3. Permit Condition 7.4 is changed to the following:

 Products containing *Bacillus thuringiensis* subsp. *israelensis* (Bti) may not be used in fish bearing waters unless WNV vector species are verified as being present. A local representative of Fisheries and Oceans Canada or Environment Canada must be consulted to determine potential fisheries impacts prior to undertaking treatments to fish bearing waters.

- Ac 4. Permit condition 7.5 is deleted.
- Ac 5. Permit conditions 6.3 and 7.3 are amended by the addition of the following sentence: "This condition does not apply to storm drains."
- Ac 6. The permit duration is extended to December 31, 2005. The permit number is changed to 776-001-2003/2005 for administrative purposes.
- Ac 7. No treatments of adulticides shall be conducted during daylight hours (i.e. adulticides may only be applied between the official times of sunset and sunrise). This amendment to the permit was made by the April 8, 2004, decision of the Environmental Appeal Board.
- Ac 8. Prior to the start of the initial adulticiding activities within each jurisdiction under this permit (i.e. within each municipality or Regional District) in each year of the permit, notification be provided to Environment Canada, Environmental Protection Branch (J. Pasternak, (604) 666-8077, or M. Wan (604) 666-3111).

All other terms of the permit shall apply.
