If your answer is “No” to the above question you will be required to carry and provide evidence of General Liability Insurance with inclusive limits of not less than \$2,000,000.00 (two million dollars) for litter pickup, weeding and planting, and not less than \$5,000,000.00 (five million dollars) for mowing.
