

**Chief Forester Order**  
**Section 173 of the *Forest Act***


I, Jim Snetsinger, Chief Forester, order that the allowable annual cut for Tree Farm Licence 47 is reduced by 10 000 cubic metres effective July 1, 2005 to account for the Haida Gwaii/Queen Charlotte Islands Designated Area (B.C. Reg 210/2005), and reduced by 7 000 cubic metres effective September 8, 2006 to account for Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 (B.C. Reg 251/2006) until either area ceases to be a designated area.

These reductions apply as follows:

- (a) the allowable annual cut reductions are attributable to old-growth timber in the Moresby Island Management Unit of Tree Farm Licence 47;
- (b) the allowable annual cut attributable to the portion of Tree Farm Licence 47 other than the Moresby Island Management Unit is unchanged.

This order cancels and replaces the order I signed on October 4, 2006, which reduced the allowable annual cut for Tree Farm Licence 47.



I, Jim Snetsinger, Chief Forester, order that the allowable annual cut for the Queen Charlotte Timber Supply Area is reduced by 37 000 cubic metres effective July 1, 2005 to account for the Haida Gwaii/Queen Charlotte Islands Designated Area (B.C. Reg 210/2005), and reduced by 69 000 cubic metres effective September 8, 2006 to account for Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 (B.C. Reg 251/2006), until either area ceases to be a designated area.

The reduction to account for Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 applies as follows:

- (a) the allowable annual cut attributable to low-volume cedar stands is reduced by 11 000 cubic metres
- (b) the allowable annual cut attributable to stands other than low-volume cedar stands is reduced by 58 000 cubic metres

This order cancels and replaces the order I signed on October 4, 2006, which reduced the allowable annual cut for the Queen Charlotte Timber Supply Area.


I, Jim Snetsinger, Chief Forester, order that effective September 8, 2006 the allowable annual cut for Tree Farm Licence 25 is reduced by 600 cubic metres to account for the Haida Gwaii/Queen Charlotte Islands Designated Area (B.C. Reg 210/2005), and reduced by 7 900 cubic metres to account for Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 (B.C. Reg 251/2006), until either area ceases to be a designated area.

These reductions apply as follows:

- (a) the allowable annual cut attributable to Block 6 of Tree Farm Licence 25 is reduced by 8 500 cubic metres;
- (b) the allowable annual cut attributable to the portion of Tree Farm Licence 25 other than Block 6 is unchanged.

This order cancels and replaces the order I signed on October 4, 2006, which reduced the allowable annual cut for Tree Farm Licence 25.




I, Jim Snetsinger, Chief Forester, order that the allowable annual cut for Tree Farm Licence 39 is reduced by 43 000 cubic metres effective July 1, 2005 to account for the Haida Gwaii/Queen Charlotte Islands Designated Area (B.C. Reg 210/2005), and reduced by 250 000 cubic metres effective September 8, 2006 to account for Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 (B.C. Reg 251/2006) until either area ceases to be a designated area.

These reductions apply as follows:

- (a) the allowable annual cut reductions are attributable to Block 6 of Tree Farm Licence 39;
- (b) the partition attributable to areas known as 'Haida declared protected areas' is reduced to zero;
- (c) the allowable annual cut attributable to the portion of Tree Farm Licence 39 other than Block 6 is unchanged.

This order cancels and replaces the order I signed on October 4, 2006, which reduced the allowable annual cut for Tree Farm Licence 39.
