

### CERTIFICATE OF EXEMPTION

# FOR CHILDREN'S CLOTHING AND FOOTWEAR

Pursuant to the Social Service Tax Act

#### Instructions to the Seller:

- This form should be completed <u>only</u> when the apparel being purchased is for children under 15 <u>and</u> the apparel is:
  - clothing larger than boys' Canada standard size 18 or girls' size 16,
  - hose larger than boys' size 10 and girls' size 9 1/2,
  - gloves larger than boys' and girls' size 7,
  - footwear larger than boys' and girls' size 6, or,
  - hats that are not designed as children's hats.
- This schedule must be retained by the seller for inspection as required by the commissioner.
- A vendor can be held liable for the tax not collected if a "Certificate of Exemption for Children's Clothing and Footwear" is not completed and signed by the purchaser.
