To All Licensed British Columbia Finfish Aquaculturists:

- 2005 Annual Aquaculture Statistical Reports due February 24, 2006
- Historical AASR for 2004, 2003, 2002 &/or 2001 Past Due

The Ministry of Environment is responsible for collecting and analyzing British Columbia seafood production statistics for both the commercial fisheries and aquaculture sectors. For aquaculture production the information is collected under authority of Section 20(1) of the *Fisheries Act* using the Annual Aquaculture Statistical Reports (AASR).

You or your company held a provincial Aquaculture Licence during 2005 and as a condition of that licence you are required to submit an annual production report to our office. Enclosed for your convenience, is a 2005 AASR for each of your licensed aquaculture operations. Remember the reports must be completed in full for all species, and returned, even if they are "NIL", to satisfy your reporting requirements.

We will be strictly enforcing the reporting deadline based upon Section 20(1) of the *Fisheries Act*. Companies or persons that have not submitted their completed Annual Aquaculture Statistical Reports by the deadline as stated in the *Fisheries Act* will be committing an offence under the *Fisheries Act* and subject to penalties and fines therein.

In addition, companies or persons with outstanding Annual Aquaculture Statistical Reports for 2005, 2004, 2003, 2003 &/or 2001 will be subject to <u>administrative</u> <u>sanctions</u> including:

- non-issuance of new species;
- no recommendation for tenure expansions; and
- no recommendation for tenure assignments.

Status of Historical AASR Reporting Requirements for you or your company:

For any outstanding historical AASR listed above we have generated new blank forms to assist you with meeting your historical reporting requirements. To ensure that you or your company is in good standing with both the Ministry of Agriculture and Lands and the Integrated Land Management Bureau, all AASR included in your package must be completed in full and returned.

Please be assured that **data from individual forms and companies will be protected** within the provisions of the *Freedom of Information and Protection of Privacy Act.* The information contained on the AASR is published only in aggregate form (combined data from three or more companies). However, please be aware that the information provided on individual AASR may be utilized by Ministry of Agriculture and Lands compliance staff as part of their mandate to monitor industry compliance.

Summary data from the census is published in the *British Columbia Seafood Industry Year in Review* and may be utilized when responding to various information requests from industry stakeholders.
