Minister of Forests Order

(Forest Act, Section 170 (2))

Haida Gwaii/Queen Charlotte Islands Designated Area No. 3

I, Rich Coleman, Minister of Forests and Range order the following with respect to the Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 established by B.C. Reg. 251/2006:

- Any person who, under the Forest Act or the Forest and Range Practices Act, has the discretion to issue a permit, licence or plan referred to in Section 170 (3) of the Forest Act to not issue the permit, licence or plan if the permit, licence or plan relates to all or part of the Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 unless it is:
 - (i) a free use permit entered into with a Haida Nation member,
 - (ii) a licence to cut entered into for a non-commercial purpose, or
 - (iii) a permit, licence or plan that is exempted as listed in Appendix A or B,
- all rights of a holder under a Cutting Permit, Road Permit, Timber Sale Licence, Licence to Cut, Special Use Permit or an operational plan that relates to the Haida Gwaii/Queen Charlotte Islands Designated Area No. 3 are suspended unless:
 - (i) the licence to cut has been entered into for a non-commercial purpose, or
 - (ii) the Cutting Permit, Road Permit, Timber Sale Licence, Licence to Cut, Special Use Permit or an operational plan is exempted as listed in Appendix A or B.
