Crown Agencies Secretariat

The registry provides Crown Agency classification and Minister Responsible listings as of December 2006. The Crown Agencies Secretariat maintains and updates the registry from time to time to ensure ongoing accuracy.

The Minister of Finance has developed a policy framework for the governance of British Columbia's Crown Agencies. The purpose of the Crown Agency Accountability System is to provide Crown Agencies with superior means to achieve government's policy and performance expectations. The system clarifies and details the respective roles of government (as the Shareholder and mandating body for Crown Agencies) and boards of directors (as the stewardship/management body with fiduciary responsibility for Crown Agency operations).

The Shareholder's Expectations Manual is a guide to the Crown Agency Accountability System, and outlines the primary responsibilities and expectations of government, Ministers Responsible, Crown Agency Board of Directors, and Ministry and Crown Agency staff relative to the governance and performance of Crown Agencies in British Columbia.

As a companion to the Shareholder's Expectations Manual and related guidelines, the Crown Agencies Secretariat, Ministry of Finance, maintains a registry for all of British Columbia's Crown Agencies. These are organizations, other than ministries, whose financial results are reported within the government reporting entity.

Crown Agencies are administered by varying degrees at arms-length from government. They are, however, within government's control under standards defined by the Canadian Public Sector Accounting Board guidelines. The primary test this for control is that government appoints more than fifty percent of the members of a Crown Agency's Board of Directors.

British Columbia's 200 plus Crown Agencies are subject to a variety of governance and accountability requirements, depending on their classification. Full explanation of these requirements is outlined in the Shareholder's Expectations Manual

Commercial and Service Delivery Crown Corporations are separate legal entities, subject to all aspects of the governance and accountability requirements outlined in the Shareholder's Expectations Manual and related guidelines.

SUCH Sector Organizations are separate legal entities, subject to accountability frameworks developed by SUCH sector ministries (Ministries of Advanced Education, Education and Health), including financial and performance reporting requirements. SUCH sector organizations are subject to the start-up and Board appointment requirements outlined in the Shareholder's Expectations Manual and related guidelines. School Boards, as elected bodies, are exempt from Board of Director requirements.

Advisory Boards are not separate legal entities, and are subject to the financial and administrative accountability mechanisms that apply to ministry branches and programs. Advisory Boards are subject to the start-up and Board appointment requirements outlined in the Shareholder's Expectations Manual and related guidelines. There are generally two types of Advisory Boards: program-level boards established to provide ongoing advice to support a government program; and, special-purpose boards established to provide government with specialized policy expertise for a fixed time.

*Tribunals* are created by statute to exercise adjudicative functions independent of government, but are subject to the same financial and administrative accountability mechanisms as ministry branches and programs. In addition to the authorities set out in their own enabling legislation, many Tribunals have additional authorities under the *Administrative Tribunals Act*. Tribunal are supported by the Administrative Justice Office.
