



## Attention: Agreement Holder,

This letter applies only to those persons required to prepare a Forest Stewardship Plan consistent with sections 3 and 4 of the *Forest and Range Practices Act*. The purpose of this letter is to notify you that, pursuant to section 7(2) of the *Forest Planning and Practices Regulation*, Notices have been produced to provide indicators of the amount of area, distribution of areas and attributes of those areas for the survival of species at risk and the winter survival of specified ungulate species.

Providing you with this notification triggers the requirement in section 7(2) of the of the *Forest Planning and Practices Regulation* for a person required to prepare a forest stewardship plan to specify results or strategies that are consistent with the objective set by government for wildlife in section 7(1) of the *Forest Planning and Practices Regulation*.
