An Act to amend *An Act to incorporate The Full Gospel Bible Institute*

(Assented to _____)

Preamble

WHEREAS the Full Gospel Bible Institute was incorporated by Chapter 103 of the Statutes of Saskatchewan, 1950; and

WHEREAS the Full Gospel Bible Institute has by petition prayed that the Act be amended to change the name to Eston College and to provide for clarification of the definition, roles and appointment of members and directors of the Institute;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 *The Eston College (Full Gospel Bible Institute Amendment) Act.*

S.S. 1950, c.103 amended

2 *An Act to incorporate Full Gospel Bible Institute* is amended in the manner set forth in this Act.

Long title amended

3 **The long title is amended by striking out “Full Gospel Bible Institute” and substituting “Eston College”.**

Section 1 amended

4 **Section 1 is amended by striking out “Full Gospel Bible Institute” and substituting “Eston College”.**

Section 3 amended

5 **Section 3 is amended by striking out “the admission and control of members”.**

Section 6 amended

6 **Section 6 is amended:**

(a) **by striking out “trustees” where it first appears and substituting “directors”; and**

(b) **by striking out “called ‘Board of Trustees’ of Full Bible Institute”.**

Section 7 amended

7 Section 7 is amended by striking out “chairman” and substituting “Chair of the Board of Directors”.

New sections 8.1 and 8.2

8 The following is added after section 8:

“Board of Directors

8.1(1) The members of the Corporation shall constitute the Board of Directors and shall consist of individuals who have:

- (a) accepted the Lord Jesus Christ as their personal saviour;
- (b) agreed to and signed the Statement of Faith of Eston College; and
- (c) been appointed by the previous Board of Directors.

“(2) No member or director of the Corporation shall be a salaried employee of the Corporation.

“(3) A member or director shall cease to be a member or director:

- (a) when the person resigns;
- (b) when the person is found guilty of conduct unbecoming a Christian as determined by majority vote of the Board of Directors;
- (c) when the person becomes incapable of holding office; or
- (d) when the person dies”.

“Annual meeting

8.2 An annual meeting of the membership shall be held at the Head Office of the Corporation or any other place as determined by the Board of Directors on the day the Board shall set”.

Transitional

9(1) Upon the coming into force of this Act:

- (a) the property of the former corporation as it existed on the day before this Act comes into force continues to be the property of the Corporation;
- (b) the Corporation continues to be liable for the obligations of the former corporation as it existed on the day before this Act comes into force;
- (c) any existing cause of action, claim or liability is not affected by the enactment of this Act and any existing cause of action, claim or liability continues to apply to the Corporation notwithstanding the enactment of this Act;

(d) a civil, criminal or administrative action or proceeding pending by or against the former corporation as it existed on the day before this Act comes into force may be continued to be prosecuted by or against the Corporation;

(e) a conviction against, or ruling, order or judgment in favour of or against the former corporation as it existed on the day before this Act comes into force may be enforced by or against the Corporation;

(f) the bylaws of the former corporation that were in force on the day before this Act comes into force continue as the bylaws of the Corporation until replaced or amended by the Corporation pursuant to this Act;

(g) a person who is a member of the board of directors of the former corporation on the day before this Act comes into force continues as a member of the board of directors until the earlier of the following dates:

(i) the date members of the board of directors are appointed to the board pursuant to this Act and the bylaws; and

(ii) the date the person dies, resigns or otherwise ceases to be a member of the board of directors.

(2) If a will, within the meaning of *The Wills Act, 1996*, made before or after the coming into force of this Act, that is probated after the coming into force of this Act directs that assets be given to the former corporation the assets that would have been given to that entity are to be given to the Corporation.

(3) Notwithstanding any other Act or law, on and from the coming into force of this Act, a reference to the former corporation in a will, bequest or gift is deemed to be a reference to the Corporation.

Coming into force

10 This Act comes into force on assent.
