#### Preamble

WHEREAS An Act to incorporate Hotels Association of Saskatchewan was assented to on April 7, 1960;

WHEREAS pursuant to said Act, the name of the corporation is stated to be "Hotels Association of Saskatchewan";

WHEREAS the Board of Directors of the Hotels Association of Saskatchewan, has passed a motion to change the name of the association to The Saskatchewan Hotel & Hospitality Association;

WHEREAS the Board of Directors of the Hotels Association of Saskatchewan wishes to expand the mandate and membership of the association to include businesses in the hospitality industry;

WHEREAS a Petition has been presented praying that an Act be passed by the Legislative Assembly of Saskatchewan to the amend *An Act to incorporate Hotels Association of Saskatchewan*;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

#### Short title

1 The Hotels Association of Saskatchewan Amendment Act.

#### S.S. 1960, c. 98 amended

**2** An Act to incorporate Hotels Association of Saskatchewan is amended in the manner set forth in this Act.

#### Long title

**3** The long title is struck out and the following substituted:

"An Act to incorporate The Saskatchewan Hotel & Hospitality Association".

#### Section 1 amended

**4** Section 1 is amended by striking out "Hotels Association of Saskatchewan" and substituting "The Saskatchewan Hotel & Hospitality Association".

#### Section 2 amended

#### 5 Section 2 is amended:

(a) in clause 2(a) by striking out "hotel and motel" and substituting "hotel, motel and hospitality".

(b) in clause 2(c) by striking out "hotels and motels" and substituting "hotels, motels and hospitality businesses".

(c) in clause 2(d) by striking out "hotels and motels" and substituting "hotels, motels and hospitality businesses".

(d) in clause 2(e) by striking out "hotels and motels" and substituting "hotels, motels and hospitality businesses".

(e) in clause 2(h) by striking out "hotel and motel" and substituting "hotel, motel and hospitality business".

(f) in clause 2(j) by striking out "hotels and motels" and substituting "hotels, motels and hospitality businesses".
