An Act to make consequential amendments to certain Acts arising from the enactment of *The Legislative Assembly and Executive Council Act, 2006*

(Assented to)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Legislative Assembly and Executive Council Consequential Amendments Act, 2006*.

Consequential amendments

2 **The provisions of the Acts set out in the Schedule to this Act are amended by striking out “*The Legislative Assembly and Executive Council Act, 2005*” and substituting “*The Legislative Assembly and Executive Council Act, 2006*”.**

3 **Subsection 11(2) of *The Government Organization Act* is amended by striking out “*The Legislative Assembly and Executive Council Act*” and substituting “*The Legislative Assembly and Executive Council Act, 2006*”.**

4 **Subsection 31(4) of *The Members’ Conflict of Interest Act* is amended by striking out “apply” and substituting “applies”.**

Coming into force

5 This Act comes into force on the day on which *The Legislative Assembly and Executive Council Act, 2006* comes into force.
