Short title

1 This Act may be cited as *The Legislative Assembly and Executive Council Consequential Amendments Act*, 2006.

2 The provisions of the Acts set out in the Schedule to this Act are amended by striking out "The Legislative Assembly and Executive Council Act, 2005" and substituting "The Legislative Assembly and Executive Council Act, 2006".
