An Act to amend *The Saskatchewan Institute of*Applied Science and Technology Act

(Assented to)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as The Saskatchewan Institute of Applied Science and Technology Amendment Act, 2006.

2 The Saskatchewan Institute of Applied Science and Technology Act is amended in the manner set forth in this Act.

Section 3 amended

3 Subsection 3(3) is amended by adding "within Saskatchewan or elsewhere" after "locations".

Section 6 amended

- 4(1) Subsection 6(1) is amended by striking out "The" and substituting "Subject to subsection (2), the".
- (2) The following subsection is added after subsection 6(1):
 - "(1.1) The Lieutenant Governor in Council shall appoint as members:
 - (a) one SIAST student;
 - (b) one member of the Saskatchewan Apprenticeship and Trade Certification Commission appointed pursuant to *The Apprenticeship and Trade Certification Act*, 1999; and
 - (c) one member of a board appointed pursuant to *The Regional Colleges Act*".

Section 8 amended

- 5 Section 8 is amended:
 - (a) in clause (c) by striking out "10" and substituting "eight"; and
 - (b) by repealing clause (f) and substituting the following:
 - "(f) for each meeting of the board or any committee of the board, provide to the minister a copy of the approved minutes, certified by the secretary of the board or the committee, together with copies of any resolutions or bylaws adopted at the meeting".

Section 9 amended

6 The following subsections are added after subsection 9(4):

- "(4.1) The board may establish any committee consisting of board members that the board considers advisable.
- "(4.2) Any committee established pursuant to subsection (4.1) shall comply, with any necessary modification, with the requirements of subsection (4)".

Section 10 amended

7 The following clause is added after clause 10(5)(a):

"(a.1) the business plan and budget".

Section 12 amended

8(1) Subsection 12(1) is repealed and the following substituted:

- "(1) Subject to subsection (3), The Public Service Superannuation Act, The Superannuation (Supplementary Provisions) Act and The Public Employees Pension Plan Act apply, with any necessary modification, to the officers and employees of SIAST".
- (2) Subclause 12(3)(a)(iv) is repealed.

Section 17 amended

- 9(1) Subsection 17(1) is amended:
 - (a) by adding "and a business plan" after "a budget"; and
 - (b) by striking out "the budget" and substituting "them".

(2) Subsection 17(2) is repealed and the following substituted:

"(2) The minister shall review the budget and the business plan submitted to him or her pursuant to subsection (1) and may approve them or may, after consultation with the board, require the board to revise all or any part of either of them in any manner that the minister considers appropriate".

(3) Subsection 17(3) is repealed and the following substituted:

"(3) On approval of the budget and the business plan by the minister, the board shall adopt them for SIAST as approved by the minister".

Section 31 amended

10(1) Subsection 31(1) is amended by striking out "shall, at least once in every five years," and substituting "may".

(2) Subsection 31(8) is repealed and the following substituted:

"(8) The committee shall provide its report to the minister by the date specified by the Lieutenant Governor in Council for its submission".

Coming into force

11 This Act comes into force on assent.
