An Act to amend The Wildlife Habitat Protection Act

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as The Wildlife Habitat Protection Amendment Act, 2006 (No. 2).

2 The Wildlife Habitat Protection Act is amended in the manner set forth in this Act.

Section 2 amended

- 3 The following clause is added after clause 2(c):
 - "(c.1) 'Schedule' means the Schedule to this Act".

Schedule amended

- 4(1) The Schedule is amended in the manner set forth in this section.
- (2) Item 204 is amended by adding the following clause after clause (i):
 - "(j) the west half of Section 33".
- (3) Item 393 is amended by striking out "east half" and substituting "south-east quarter".
- (4) Item 413 is amended by adding the following clause after clause (a):
 - "(a.1) Legal Subdivision 12 of Section 11".
- (5) Clause (p) of item 652 is amended by striking out "south half and north-west quarter" and substituting "south-east and north-west quarters".
- (6) Item 737 is repealed and the following substituted:

"737 All those lands in Township 50, in Range 2, west of the Third Meridian, described as follows:

- (a) the north-east quarter of Section 20;
- (b) the south-west quarter of Section 28;
- (c) Section 29".

- (7) Clause (u) of item 976 is amended by striking out "and north-east quarter".
- (8) Clause (f) of item 1062 is repealed and the following substituted:
 - "(f) Section 22".
- (9) Clause (a) of item 1107 is repealed.
- (10) Item 1223 is amended by repealing clause (a) and substituting the following:
 - "(a) the west half of Section 1;
 - "(a.1) the south-east quarter of Section 4".
- (11) Clause (a) of item 1257 is repealed and the following substituted:
 - "(a) that portion of the west half of Section 12 that is Crown owned".
- (12) Item 1441 is amended by adding the following clause after clause (n):
 - "(n.1) the south half of Section 29".

Certain withdrawn lands re-designated

- **5**(1) In this section, **"indicated lands"** means the following lands listed in the Schedule to *The Wildlife Habitat Protection Act*:
 - (a) the north half of Section 29, in Township 36, in Range 32, west of the First Meridian;
 - (b) that portion of the north-west quarter of Section 5 lying to the right of the right bank of the North Saskatchewan River in Township 40, in Range 11, west of the Third Meridian;
 - (c) the south-west quarter of Section 11, in Township 41, in Range 15, west of the Third Meridian;
 - (d) the east half of Section 12, in Township 55, in Range 26, west of the Third Meridian;
 - (e) the south-east quarter of Section 15, in Township 55, in Range 26, west of the Third Meridian.
- (2) Notwithstanding any regulations made pursuant to clause 9(1)(b) of *The Wildlife Habitat Protection Act*:
 - (a) the withdrawal of the indicated lands is revoked; and
 - (b) the indicated lands are re-designated as wildlife habitat lands and are to be dealt with pursuant to *The Wildlife Habitat Protection Act* as wildlife habitat lands.
