and the proposed amendment thereto moved by Mr. Duncan, seconded by Mr. D'Autremont:

That the following words be added after the word "Session":

and that this government no longer enjoys the confidence of this Assembly because of its lack of vision and initiative in finding solutions to the growing labour shortage, the out-migration of our youth and families, forcing Saskatchewan people to go out of province for health care, failing to deal with the agricultural crisis and its impact on rural Saskatchewan, failing to protect children who are at risk, and for being too focused on its internal partisan political problems.

### **QUESTIONS AND ANSWERS**

# Mr. Weekes asked the Government the following Question No. 2, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: For 2005/06 fiscal year, what are the reasons for rejecting any applications through the Saskatchewan Immigrant Nominee Program?

### Answer:

In general, applications are rejected because:

- they do not meet program or category criteria;
- the applicant did not provide sufficient information and was sent at least one reminder;
- supporting documentation is found to be inadequate or unsubstantiated; and
- there is reason to believe that the applicant or their accompanying family members will not meet federal statutory health, criminality or background requirements.

# Mr. Weekes asked the Government the following Question No. 3, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: To date, with a breakdown for 2006, how many applications did the Saskatchewan Immigrant Nominee Program reject?

#### Answer:

From January 1, 2006 to September 30, 2006, the SINP rejected 32 applications.

# Mr. Weekes asked the Government the following Question No. 4, which was answered by the Hon. Ms. Atkinson:

To the Minister Responsible for Immigration: To date, with a breakdown for 2006, how many applications did the Saskatchewan Immigrant Nominee Program approve?

### Answer:

From January 1, 2006 to September 30, 2006, the SINP approved 613 applications.

#### Answer:

As of September 2006, 24 people are employed to administer the Saskatchewan Immigrant Nominee Program.

# Mr. Dearborn asked the Government the following Question No. 8, which was answered by the Hon. Ms. Higgins:

To the Minister Responsible for Saskatchewan Liquor and Gaming Authority: (1) What are SLGA's standard auditing procedures for VLTs? (2) Who performs the audit? (3) When were the procedures last updated?

#### Answer:

The Saskatchewan Liquor and Gaming Authority (SLGA) has a number of control processes that contribute to the integrity of the operation of the VLTs:

- SLGA is audited annually by the Provincial Auditor;
- Western Canada Lottery Corporation (WCLC), SLGA's agent for operation of the VLT Program, is audited annually by a national accounting firm, Deloitte & Touche;
- One of SLGA's conditions of purchase include the VLTs being approved by an independent testing laboratory to ensure their integrity, prior to being introduced into the marketplace;
- WCLC performs quality assurance testing on the VLTs to provide additional assurance of their integrity;
- SLGA's Compliance Branch performs regular, random, independent checks of all VLTs throughout Saskatchewan and investigates complaints from players with respect to electronic gaming machines to ensure the machines are operating correctly and players are being treated fairly.

Auditing procedures are updated on a regular basis as national standards change.

To the Minister Responsible for Saskatchewan Liquor and Gaming Authority: Has SLGA audited any winnings of its VLTs purchased or leased from WMS Gaming?

### Answer:

No, currently SLGA does not have WMS Gaming machines within its VLT program.

The Saskatchewan Liquor and Gaming Authority does not have any VLTs purchased or leased from WMS Gaming.
