### **QUESTIONS AND ANSWERS**

# Mr. Merriman asked the Government the following Question No. 71, which was answered by the Hon. Mr. Belanger:

To the Minister of Community Resources: What process and procedure does the Red Willow Centre in Saskatoon follow when a child runs away from the facility?

#### Answer:

It is the policy of Red Willow to pursue youth who are fleeing whenever possible, taking into consideration the safety of other children in Red Willow Centre. Not all children who run are leaving from the residential centre. They may decide to run while attending school, community outings and programs or while participating in a home visit. When a child is on the run, police, family, and regional workers are notified of the time the child left and the time of their return. Staff persons make daily efforts to locate the child and every lead is followed to bring about their safe return to the program. Red Willow staff take the lead in searching for children who have run away. When children are listed as missing with police, the following information is provided:

- a. Name and basic demographic information of the child;
- b. When the child left;
- c. Where the child left from;
- d. What the child was wearing;
- e. Any known behaviours or interactions that may have precipitated the child's departure;
- f. Any possible places the child may go;
- g. Any special physical or mental health conditions or medications that may affect the child's safety;
- h. Any known companions who may be aware of and involved in the child's absence;
- i. Other professionals, relatives, significant adults or peers who may know where the child might go; and
- j. A recent photo of the child (if available or requested).

## Ms. Harpauer asked the Government the following Question No. 72, which was answered by the Hon. Mr. Sonntag:

To the Minister of Crown Investments Corporation of Saskatchewan: (1) What is the CIC Social Club? (2) Why did CIC pay it \$7,200 in 2005?

#### Answer

- (1) The Social Fund is where employees contribute \$4 per month through an automatic deduction on their pay cheque. At the end of each year CIC matches employee contributions with the intent of building a positive work environment.
- (2) CIC's \$7,200 payment to the Social Fund accounts for the corporation's matching contributions to the fund for both fiscal years 2004 and 2005. This included contributions to the Salvation Army's Adopt-a-Family Christmas Hamper Program:

2004 – CIC Social Fund Contribution Adopt-a-Family	\$2,965 <u>815</u> \$3,780
2005 – CIC Social Fund Contribution Adopt-a-Family	\$2,928 <u>485</u> \$3,413
Total	\$7,193

# Ms. Harpauer asked the Government the following Question No. 73, which was answered by the Hon. Mr. Sonntag:

To the Minister of Crown Investments Corporation of Saskatchewan: (1) What is Skills Canada Alberta? (2) Why did CIC pay it \$10,000 in 2005?

#### Answer:

- (1) Skills Canada Alberta is Alberta's counterpart to Skills Canada Saskatchewan. It is a non-profit provincial association, which works with employers, educators, labour groups and the government to promote trade and technical careers as a career option.
- (2) The payment identified in the 2005 Payee Disclosure Report is an error. The \$10,000 payment was made to Skills Canada Saskatchewan, not Skills Canada Alberta. No payment was made directly by CIC to Skills Canada Alberta.

## Ms. Harpauer asked the Government the following Question No. 74, which was answered by the Hon. Ms. Higgins:

To the Minister Responsible for Saskatchewan Telecommunications: Why was the remuneration of two members of the board of directors paid directly to the CEP Council in 2005?

### Answer:

The two members are SaskTel employees who are appointed to the board as representatives of the Communication, Energy and Paperworkers Union (CEP). The members are entitled to an annual retainer which SaskTel pays to the CEP who in turn pays the two board members.

## Ms. Harpauer asked the Government the following Question No. 75, which was answered by the Hon. Ms. Higgins:

To the Minister Responsible for Saskatchewan Telecommunications: (1) For how much money did SaskTel sell Business Watch International? (2) To whom was it sold?

#### Answer:

- (1) SaskTel sold its share in Business Watch International for \$574,000.00.
- (2) The shares were sold to the founders of Business Watch International Progressive Communications Inc. and On-Line Regina Inc.

## Ms. Harpauer asked the Government the following Question No. 76, which was answered by the Hon. Ms. Higgins:

To the Minister Responsible for Saskatchewan Telecommunications: (1) What was the cost of the initial investment into Business Watch International? (2) From whom did SaskTel purchase the company?

### Answer:

- (1) The cost of the initial investment into Business Watch International was \$310,000.00.
- (2) SaskTel did not purchase the company, but rather purchased its share of Business Watch International directly from the company.

## Ms. Harpauer asked the Government the following Question No. 77, which was answered by the Hon. Mr. Lautermilch:

To the Minister Responsible for Saskatchewan Transportation Company: (1) How many STC agencies were closed in 2006? (2) Which ones were they? (3) Why were they closed?

### Answer:

- (1) 18.
- (2) Duval, Meyronne, Southey, Dafoe, Dubuc, Holdfast, Kincaid, Lumsden, Meadow Lake, Warman, Luseland, Mistatim, Nokomis, Oxbow, Pleasantdale, Quinton, Shaunavon, Spaulding.

(3) Duval, Meyronne, Southey, Dafoe, Kindcaid, Meadow Lake, Mistatim and Shaunavon closed when the businesses which operated them closed. In all other cases, the business chose to no longer act as an STC agent. There will be no agent in Duval, as the business has too low a volume, and there will be no agent in Meyronne, as there are no other businesses in the community. STC is searching for a replacement agent in Southey. In all other communities, a replacement agent has been found.

### Mr. Huyghebaert asked the Government the following Question No. 78, which was answered by the Hon. Mr. Lautermilch:

To the Minister of Highways and Transportation: (1) In this fiscal year, is there money in the Department of Highways and Transportation's budget to cover a financial settlement with the Notekeu Flood Group? (2) If so, what is the amount earmarked for the Notekeu Flood Group?

#### Answer:

- (1) No.
- (2) None.

## Mr. Hart asked the Government the following Question No. 79, which was answered by the Hon. Mr. McCall:

To the Minister of Corrections and Public Safety: (1) How many people were evacuated from Fond du Lac during the summer of 2006 as a result of forest fires? (2) How many days were the evacuated people away from their homes? (3) What was the cost of the evacuation for Fond du Lac?

#### Answer:

As the responsibility for this subject lies with the Department of Community Resources, they have provided the answer.

- (1) 364.
- (2) Evacuation began on June 27, 2006. Evacuees' return was completed on July 2, 2006.
- (3) \$278,592.89

### Mr. Hart asked the Government the following Question No. 80, which was answered by the Hon. Mr. McCall:

To the Minister of Corrections and Public Safety: (1) How many people were evacuated from Stony Rapids during the summer of 2006 as a result of forest fires? (2) How many days were the evacuated people away from their homes? (3) What was the cost of the evacuation for Stony Rapids?

### Answer:

As the responsibility for this subject lies with the Department of Community Resources, they have provided the answer.

- (1) 205.
- (2) On June 25, 2006 civic officials evacuated a number of Stony Rapids residents to Black Lake. Provincial government began evacuating residents from both communities on June 26, 2006. Evacuees' return was completed on July 2, 2006.
- (3) \$169,810.76

## Mr. Hart asked the Government the following Question No. 81, which was answered by the Hon. Mr. McCall:

To the Minister of Corrections and Public Safety: (1) How many people were evacuated from Black Lake during the summer of 2006 as a result of forest fires? (2) How many days were the evacuated people away from their homes? (3) What was the cost of the evacuation for Black Lake?

#### Answer:

As the responsibility for this subject lies with the Department of Community Resources, they have provided the answer.

(1) 412.

- (2) Evacuations began on June 26, 2006. Evacuees' return was completed on July 2, 2006.
- (3) \$317,373.28

## Mr. Hart asked the Government the following Question No. 82, which was answered by the Hon. Mr. McCall:

To the Minister of Corrections and Public Safety: (1) How many people were evacuated from Uranium City during the summer of 2006 as a result of forest fires? (2) How many days were the evacuated people away from their homes? (3) What was the cost of the evacuation for Uranium City? Answer:

As the responsibility for this subject lies with the Department of Community Resources, they have provided the answer.

- (1) 17.
- (2) Most residents of Uranium City self evacuated on June 29, 2006. Evacuees' return was completed on July 1, 2006.
- (3) \$14,270.72

## Ms. Draude asked the Government the following Question No. 83, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: In which residential or group homes are the 41 designated spaces for children and youth at risk of being sexually exploited?

#### Answer:

The Department of Justice does not have responsibility for this.

## Ms. Draude asked the Government the following Question No. 84, which was answered by the Hon. Mr. Ouennell:

To the Minister of Justice: How much money has the Government of Saskatchewan put into Saskatoon Safe Houses for the fiscal year 2005?

### Answer:

The Department of Justice contributed \$65,350 to the jointly funded Saskatoon Safe Houses for the fiscal year 2005-2006.

## Ms. Draude asked the Government the following Question No. 85, which was answered by the Hon. Mr. Ouennell:

To the Minister of Justice: How much money has the Government of Saskatchewan put into Saskatoon Safe Houses for the fiscal year 2004?

### Answer:

The Department of Justice contributed \$64,900 to the jointly funded Saskatoon Safe Houses for the fiscal year 2004-2005.

### Ms. Draude asked the Government the following Question No. 86, which was answered by the Hon. Mr. Ouennell:

To the Minister of Justice: How much money has the Government of Saskatchewan put into Saskatoon Safe Houses for the fiscal year 2003?

### Answer:

The Department of Justice contributed \$64,900 to the jointly funded Saskatoon Safe Houses for the fiscal year 2003-2004.

#### Answer:

The Department of Justice contributed \$58,000 to the jointly funded Saskatoon Safe Houses for the fiscal year 1999-2000.

### Ms. Draude asked the Government the following Question No. 91, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: How many homes or properties have been shut down under *The Safer Communities and Neighbourhoods Regulations* because of child sexual exploitation?

### Answer:

One case in 2005 for child sexual abuse. Zero closures to date for child exploitation.

### Ms. Draude asked the Government the following Question No. 92, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: What was the total amount collected in fines through violations of *The Highway Traffic Act* for the fiscal year 2001-02?

#### Answer:

The total collected under *The Highways and Transportation Act, 1997*, for the fiscal year 2001-02 was: \$3,412,775.

## Ms. Draude asked the Government the following Question No. 93, which was answered by the Hon. Mr. Ouennell:

To the Minister of Justice: What was the total amount collected in fines through violations of *The Highway Traffic Act* for the fiscal year 2002-03?

#### Answer

The total collected under *The Highways and Transportation Act, 1997*, for the fiscal year 2002-03 was: \$3,304,598.

# Ms. Draude asked the Government the following Question No. 94, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: What was the total amount collected in fines through violations of *The Highway Traffic Act* for the fiscal year 2003-04?

### Answer:

The total collected under *The Highways and Transportation Act, 1997*, for the fiscal year 2005-06 was: \$2,616,339.

# Ms. Draude asked the Government the following Question No. 97, which was answered by the Hon. Mr. Quennell:

To the Minister of Justice: Could the Minister provide a copy of the proposed amendments to the Criminal Code by the provincial Minister of Justice that would create a presumption that those driving a vehicle in an area frequented by prostitutes and have a child enter their vehicle are communicating with the child for the purpose of prostitution?

#### Answer:

The Provincial Minister of Justice, then the Honourable Chris Axworthy, proposed to the Federal Minister of Justice, then the Honourable Martin Cauchon, that section 212 of the *Criminal Code* be amended by adding a new subsection (4.1) which would state:

(4.1) For the purposes of subsection (4), evidence that a person was in a motor vehicle, in an area frequented by prostitutes, and that a person who is under the age of eighteen years entered the motor vehicle in that area is, in the absence of evidence to the contrary, proof that the person communicated for the purpose of obtaining for consideration the sexual services of a person who is under the age of eighteen years.

To the Minister of Justice: Could the department provide a list of the range of victim services, including compensation that is available to sexually exploited children?

#### Answer:

- Seventeen Police-based Victim Services Programs, and an additional two programs to open early in 2007/08, which provide support, information and referrals to victims;
- Six Aboriginal Resource Officer Programs, which work as part of their respective Police-based Victims Services Program to assist Aboriginal victims;
- Four Victim/Witness Programs which assist children and other vulnerable witnesses who are required to testify in court;

- The 24-hour Sexual Assault and Information Line at the Regina Women's Community Centre;
- The Victims Support Worker Program at the Saskatoon Sexual Assault and Information Centre;
- The Street Worker's Advocacy Program in Regina, which operates a street outreach program and drop-in centre for those working in street prostitution and for youth who are at risk for street involvement:
- The Victims Compensation Program, which provides payment to victims for reasonable expenses resulting from violent crimes; and,
- The Victim Impact Statement Program, which gives victims the opportunity to tell the judge how a crime has affected him, before an offender is sentenced.

#### Answer:

Our Student Data System (SDS) is "live" and on-line for use by schools, K- 12, province wide. The new, enhanced SDS became available for schools to use in October 2004. The SDS and its capacity to monitor and track student enrolment across the provincial schools has drawn interest from other provinces as similar models are being considered and developed. A high school in Saskatoon recently reported that in past years they were searching for nearly 40 students at a time; the enhanced SDS has reduced this number down to eight. The gain in efficiency is significant, and allows for more focused work on those students who actually need assistance.
