Patients are assessed by nephrologists as to their suitability to receive dialysis services at a satellite. Patients requiring hemodialysis from or near a community with a satellite program receive treatment in Regina or Saskatoon until the patient is deemed suitable for treatment at a satellite and space is available. In April 2006, the Tisdale site expanded from 3 stations to 4 stations.

In 2006, collection of information began on the number of patients suitable for satellite treatments. On November 1, 2006 the following number of patients were receiving dialysis in Regina or Saskatoon pending an opening at the satellite closer to home:

- Prince Albert – 6 patients
- Tisdale – 0 patients
- Lloydminster – 0 patients
- Yorkton – 12 patients
- Swift Current – 5 patients
- North Battleford – 6 patients
- Moose Jaw – 8 patients

**Mr. Dearborn asked the Government the following Question No. 219, which was answered by the Hon. Mr. Taylor:**

To the Minister of Health: Is the Minister aware of the current funding shortfall at the long-term care home in Eatonia?

Answer:

Saskatchewan Health licenses a 24-bed personal care home in Eatonia. Saskatchewan Health recently has become aware this facility has been experiencing financial difficulties. Saskatchewan Health's role respecting personal care homes is one of licensing and monitoring to ensure that the residents who live in these homes receive safe and adequate care.

Personal care homes (including for profit and non-profit), while monitored and regulated by Saskatchewan Health, are privately owned and operated by individuals or corporations with no public funding. The expenses of operating a personal care home usually influence the resident fees. It is our understanding that some communities fundraise to help keep resident fees lower.

**Mr. Dearborn asked the Government the following Question No. 220, which was answered by the Hon. Mr. Taylor:**

To the Minister of Health: What will happen to the residents of the long-term care home in Eatonia when it ceases operations because of the funding shortfall?

Answer:

Should a personal care home close operation, residents and families usually work with health region staff to find suitable care and accommodation options, often in another personal care home. Personal care homes (including for profit and non-profit), while monitored and regulated by Saskatchewan Health, are privately owned and operated by individuals or corporations with no public funding. There are currently 8 personal care homes with a total of 70 personal care home beds in the Heartland Health Region.

Saskatchewan Health provides global funding to regional health authorities for special care homes and community based long-term care services, such as homecare for individuals who require such care. If a resident has sufficient need as assessed by health region staff, they may be offered placement in a publicly subsidized special-care home.

**Mr. Dearborn asked the Government the following Question No. 221, which was answered by the Hon. Mr. Taylor:**

To the Minister of Health: What will be the cost of housing the 18 current residents of the long-term care home in Eatonia in hospital care?

Answer:

Typically these individuals would not require acute care. In the Heartland Health Region, the daily cost of an acute care bed is approximately \$520.00. The daily acute care bed cost varies greatly from hospital to hospital depending on the type of care delivered.
