Karl Frank Klein, who passed away on June 22, 2006, was a Member of this Legislative Assembly from 1956 until 1964 representing the constituency of Notukeu – Willow Bunch for the Liberal Party.

Mr. Klein was born on October 17, 1922 in Lafleche. He married Agnes McCarthy on July 1, 1948 and together they had six children. Mr. Klein received his early education in local schools before enlisting in the Royal Canadian Navy in 1940. He served overseas as a wireless telegraphist until 1945. Upon his return, Mr. Klein attended Teachers College in Regina. He completed his degree in Education at the University of Manitoba.

Mr. Klein's teaching career extended over twenty-seven years. He also found time to farm and to participate in the activities of his local church and the Knights of Columbus. Mr. Klein served two terms in this Assembly, winning his seat in the 1956 and the 1960 general elections.

In recording its own deep sense of loss and bereavement, this Assembly expresses its most sincere sympathy with members of the bereaved family.

Bernard Leo Korchinski, who passed away on October 13, 2006, was a Member of this Legislative Assembly from 1948 until 1952 and from 1956 until 1960 representing the constituency of Redberry for the Liberal Party.

Mr. Korchinski was born on Christmas Day, 1905 at Beaver Hill, near Ituna. He was educated at schools in Ituna, Yorkton and Regina before attending the University of Saskatchewan. He married Slawka Marak on July 21, 1938. He is survived by his four children and numerous grandchildren, greatgrandchildren and five great-grandchildren.

Mr. Korchinski's teaching career spanned thirty-nine years and schools throughout Saskatchewan. During the Second World War, he took a leave from teaching to work for the National Film Board showing newsreels and promoting war bonds. Mr. Korchinski's public service also included periods as the provincial director of the Emergency Measures Organization and as a citizenship court judge. He served two terms in this Assembly.

Joseph Clifford McIsaac, who passed away on July 25, 2006, was a Member of this Legislative Assembly from 1964 until 1974 representing the constituency of Wilkie for the Liberal Party.

Dr. McIsaac was born in Mount Herbert, Prince Edward Island on August 30, 1930. He attended local schools before graduating from the Prince of Wales College in Charlottetown. Dr. McIsaac continued his studies at the Nova Scotia Agricultural College, from which he received his diploma in 1950. Later he was awarded a Doctor of Veterinary Medicine in 1955 from the Ontario Veterinary College in Guelph. Dr. McIsaac married Marie Vandervoort on July 29, 2006. He is survived by his wife and their six children.

Dr. McIsaac began his veterinarian career by opening a practice in Unity. He expanded his interests in the farming field by establishing a commercial beef operation and a mobile feed milling company. In later years, he moved his practice to North Battleford.

Dr. McIsaac was active in a number of community and professional organizations. He belonged to the Knights of Columbus and served on the local school board and the Saskatchewan School Trustee Association. His professional interests led to his involvement with a number of cattle, farming and veterinary medical associations. Dr. McIsaac was appointed to the Canadian Dairy Commission and served as chair of the National Farm Products Marketing Council.

Saskatchewan Water Corporation has no operations in or on the NW Quarter 18-2-3 W2M, and this land is not the responsibility of Saskatchewan Water Corporation. Saskatchewan Water Corporation was not responsible for any construction projects on the NW Quarter 18-2-3 W2M, and no fence on that land was tendered or paid for by Saskatchewan Water Corporation.

When market research services are tendered, a Request for Proposal is issued to qualified suppliers. Responses are received and the following criteria are used to evaluate the responses: quality of the proposal provided by the supplier, the supplier's industry experience related to the needs of the client, supplier delivery of service standards, cost and the quality of the supplier's presentation.

As a result, the Department is unable to provide an estimate of the possible costs of such initiatives. In addition, Saskatchewan Finance has not been advised of any analysis conducted by the federal government on broadening the new income splitting provision to other income sources, either for seniors or more generally for all taxpayers.

Mr. Cheveldayoff, asked the Government the following Question No. 325, which was answered by the Hon. Mr. Thomson:

To the Minister of Finance: How much would it cost the Saskatchewan government to allow seniors couples to split all of their taxable income in the calculation of Saskatchewan income tax?

Answer:

Saskatchewan Finance generally relies on the federal government to conduct financial and distributional analysis for changes that affect the common definition of taxable income. As a result, the Department is unable to provide an estimate of the possible costs of such initiatives. Saskatchewan Finance has not been advised of any analysis conducted by the federal government on broadening the new income splitting provision to other income sources, either for seniors or more generally for all taxpayers.

Mr. Cheveldayoff, asked the Government the following Question No. 326, which was answered by the Hon. Mr. Thomson:

To the Minister of Finance: How much would it cost the Saskatchewan government to allow seniors couples to split pension income in the calculation of Saskatchewan income tax?

Answer:

The federal government estimates that its new income splitting initiative for seniors will provide about \$650 million in tax savings in 2007, with about \$15 million of this provided to Saskatchewan seniors. Using this federal information as a basis, it is estimated that this initiative will result in a provincial income tax reduction of about \$10 million per year.

Mr. Cheveldayoff, asked the Government the following Question No. 327, which was answered by the Hon. Mr. Thomson:

To the Minister of Finance: (1) Does the provincial government intend to allow seniors couples to split pension income for the purposes of calculating their provincial income tax? (2) If not, what problems will this cause in terms of tax filing for Saskatchewan seniors, as Saskatchewan income tax is currently based on the federal rules for calculating taxable income?

Answer:

- (1) While the federal government has not yet introduced the legislation necessary to allow for pension income splitting between Canadian resident spouses, it appears that this change will alter the common national definition of taxable income.
- (2) Under the terms of the federal-provincial income tax collection agreement, Saskatchewan (and all other participating provinces) has agreed to adopt the national taxable income base for provincial income tax purposes. The federal measure will therefore automatically be incorporated into the determination of provincial income taxes for all participating provinces including Saskatchewan.

Mr. Cheveldayoff, asked the Government the following Question No. 328, which was answered by the Hon. Mr. Thomson:

To the Minister of Finance: (1) Does the federal government's decision to allow seniors couples to split pension income for the purposes of calculating federal income tax affect provincial income taxes in any way? (2) If so, how?

Answer:

- (1) It is our understanding that the federal measure to allow for pension income splitting between Canadian resident spouses alters the common national definition of taxable income. Under the terms of the federal-provincial income tax collection agreement, Saskatchewan (and all other participating provinces) has agreed to adopt the national taxable income base for provincial income tax purposes. The federal measure will therefore automatically be incorporated into the determination of provincial income taxes for all participating provinces.
- (2) Federal estimates indicate that this initiative will provide about \$650 million in tax savings in 2007, with about \$15 million of this provided to Saskatchewan seniors. Saskatchewan Finance estimates that this initiative, because it adjusts the taxable income base, will automatically result in a provincial income tax reduction of about \$10 million per year.
