Payable to Minister of Finance

Wholesalers	- Attach copies of completed Forms 30B and 35B	
Retailers	- Attach Form 40B	
Item 2	- Commission is calculated as follows: 3% on the first \$1,000 tax collected shown in Item 1 and 1/4% on the balance of tax collected. Maximum annual commission - \$10,000. Commission is not allowed on returns that are filed late.	
Item 4	- Penalty at the rate shown is due on the net tax payable (Item 3) if not remitted by the due date. Maximum penalty per return period - \$500.00	
Item 5	- Interest at % per annum is due on net tax payable (Item 3) for number of days tax is overdue.	
Item 7	- The balance shown is due to adjustments for previous periods. It should be	

added if it is preceded by a '+' sign and subtracted if it is preceded by a "-" sign.
