This application must be completed if you wish to file and pay provincial tax returns through the Internet or to authorize a 3<sup>rd</sup> party (e.g. accounting firm) to e-file tax returns on your behalf. When registered, you will have access to your tax transactions through the Internet.

Once your application is processed, you will be issued a unique User ID and Password to access this service. For security purposes, these will be mailed separately, two to three days apart, to the address and attention of the person named in question 6 below. Once registered, it is not mandatory that you file your tax returns through the Internet. You may simply wish to use the system to view your recent tax transactions and account balance information.

A separate application form must be submitted if you wish to e-file for more than 2 tax accounts.
