Saskatchewan Government
Relations has participated with
other provinces and territories in
developing a report on resourcedependent rural communities
facing industry closure. As part
of the research, case studies
were developed on 16 resourcedependent communities across
Canada that had faced industry
closure, including the
communities of Uranium City,
Omega and Meadow Lake in
Saskatchewan

A report entitled Facing the Challenge of Industry Closure: Managing Transition in Rural Communities has been completed. The report provides insights into the context, circumstances and actions that influence the recovery of resource-dependent rural communities facing the crisis of industry closure.

The Weyburn Security Bank once issued its own currency which was widely accepted in the local marketplace.

The Weyburn Security Bank was established in 1911 as the first and only chartered bank with its head office in Saskatchewan.

One of the most prominent figures involved in the formation of the Weyburn Security Bank was local resident Frank Moffet.

Following a period of financial turmoil, the Weyburn Security Bank, as well as its building, was purchased by the Imperial Bank of Canada, which later merged with the Canadian Bank of Commerce to form the Canadian Imperial Bank of Canada (CIBC).

Legislation Introduced in the Spring Session

Len Taylor, Minister of Government Relations, introduced four bills in the Legislature. Bill 104 - The Planning and Development Amendment Act, 2005 and Bill 105 - The Local Government Election Amendment Act, 2005 were introduced April 8, 2005. Bill 106 - The Municipalities Act and Bill 107 - The Municipalities Consequential Amendment Act, 2005/Loi de 2005 sur les modifications correlatives découlant de la loi intitulée The Municipalities Act were both introduced on April 18, 2005.

Bill 115 - *The Education*Property Tax Credit Act, which is also of interest to municipalities, was introduced in the house on April 19, 2005, by Andrew Thomson, Minister of Learning.
