Message from Minister Taylor

Congratulations to Councillors elected at the November Rural Municipal Elections. To those of you, who are new to municipal government, welcome.

Mayors, Reeves and Councillors are a vital link to the strength of our province. Saskatchewan communities are fortunate to have dedicated people like you, providing local governance. We are facing incredible changes globally that affect the way we make decisions at all levels of government. It is your dedication that will serve local governments well as we look cooperatively at changes now to ensure the municipal sector remains strong into the future.

The Throne Speech outlined a vision for the next century, building upon the successes of the past and the hopes and dreams of the future. Zoning bylaw, basic planning statement and development plan bylaw amendment procedures

On July 1, 2005 amendments to *The Planning and Development Act, 1983* relating to Public Participation in Bylaws were proclaimed. These amendments apply to development plans, basic planning statements or zoning bylaws.

The date of the first public notice of a proposed amendment to or repeal of an existing bylaw must be published at least two weeks before the date of the public hearing to consider presentations respecting council's proposal. Previous to the amendment the required time was three weeks.

The date of the first public notice of new development plans, basic planning statements or zoning bylaws must be at least four weeks before the public meeting. This requirement has not changed.

Community planning day

The Honourable Len Taylor, Minister of Government Relations declared November 8th as Saskatchewan's inaugural Community Planning Day. This special day was held in conjunction with the Association of Professional Community Planners of Saskatchewan. The Association celebrates its 40th anniversary this year. This year Saskatchewan has joined 30 countries on four continents in celebrating November 8 as World Town Planning Day (in Saskatchewan called Saskatchewan Community Planning Day) to raise awareness of how urban and regional planning helps to build healthy and vibrant communities

Rural municipality elections

Rural Municipalities (RM) have just held elections for councillors in even numbered divisions. With elections over, Government Relations wishes to congratulate returning and new RM officials; the work you do on behalf of your ratepayers is very important.

To assist RM officials with their duties, the department has developed the *Municipal Council Handbook* and the Municipal Council Meeting *Guide*. Water treatment plant provides quality water

Congratulations to the <u>Town of</u> <u>Langham</u> on the opening of its new water treatment plant.

The plant can produce approximately 200,000 imperial gallons of water per day. That amount can be expanded, as the system was designed and built for future growth.

New ground water wells eliminate raw water safety hazards due to surface water contamination and ensure maintenance of potable water quality during peak summertime demand. Dedicated storage enhances fire fighting capacity.

"We now have a reliable supply of excellent quality water," says Langham Mayor, Emery Ens. "Our community and the environment will both benefit from this project."

State-of-the-art facility to open in Swift Current

Swift Current is known as the city where *life makes sense*. Part of this distinction comes from the city's focus on becoming a leader in providing safe, environmentally-friendly infrastructure for its residents.


The construction of a new advanced wastewater facility is an example of that focus. The biological nutrient removal plant will reduce pollutants found in wastewater before they're discharged back into the environment.

The high quality effluent produced can be discharged on a continuous basis into the Swift Current Creek. The highly beneficial and cost effective effluent disposal as irrigation to local farmland will be maintained.

Having the ability to treat the City's effluent in a non weather dependence system will free up valuable storage capacity in the existing lagoon system. This will in turn provide positive benefits to residents and increase economic growth, paving the way for new industry to settle in <u>Swift Current</u>.

Did you know?

In the last edition of Municipalities Today, there was a quick note on the gender breakdown of elected officials in Saskatchewan's municipalities. This month, similar information is provided on administrators in Saskatchewan's municipalities.



72% OF ALL MUNICIPAL ADMINISTRATORS ARE FEMALE

There are approximately 699 chief administrators in Saskatchewan municipalities. Of that number, 501 are female (for 72%) and 198 are male (for 28%). Urban municipalities employ 80% women as chief administrators, rural municipalities employ 62% women, while northern municipalities employ 83% women. Saskatchewan's cities stand out in contrast to other municipalities with 100% of city managers being male.

The overall number of 72% women stands in marked contrast to the elected officials, of whom approximately 82% are male and only 18% female.

While Saskatchewan municipal councils tend to be dominated by men, the position of chief administrator in Saskatchewan municipalities tends to be dominated by women.
