1. Make sure all areas on the forms are completed in full, and signed and dated where required.

2. The fees to incorporate are:

Name Availability Search \$ 50.00

Incorporation \$\frac{\\$265.00}{\}\$ (or \\$215.00 if incorporated on-line)

Total \$\frac{\\$315.00}{\}\$ (or \\$265.00 if incorporated on-line)

- * All fees must be paid before the forms can be approved.
- * Make remittance payable to the Minister of Finance, (in Canadian Funds).
- * Payment can be made by:

Cash/Cheque/Money Order or

Visa/MasterCard.

3. You may fax the incorporation documents (plus authorize payment by Visa, MasterCard). If you fax the documents **<u>DO NOT</u>** mail the originals – keep them for your files. The faxed copy must be legible and suitable for imaging. If the fax copy is not legible, you will be asked to submit the originals.

Your documents will not be registered until the completed documents, acceptable for processing, and fees have been received.

STARTING A BUSINESS IN SASKATCHEWAN LICENCE AND REGISTRATION REQUIREMENTS

1. Municipal or City Business Licence: - required in each municipality in which your business operates.

2. Education and Health Tax Licence (also known as PST): required by all retail businesses selling tangible goods and services.
