# THE NON-PROFIT CORPORATIONS ACT, 1995 EXTRA-PROVINCIAL REGISTRATION KIT

#### **INTRODUCTION**

Every non-profit corporation carrying on activities in Saskatchewan may register under *The Non-profit Corporations Act*, 1995. However, if the corporation "carries on business" in Saskatchewan it is required to be registered. A corporation is deemed to be carrying on business if it holds title or interest in land, maintains an office, warehouse, place of business or telephone, in Saskatchewan.

#### PROCEDURE FOR REGISTRATION

It is necessary to check with the Corporations Branch to determine whether the name of the corporation is available for registration. The name may be too similar to that of another corporation or firm.

Form 27 entitled Request for Name Search and Reservation is designed for a name availability search and reservation. A name may be searched and reserved by calling (306) 787-2962. When calling, be prepared to provide the clerk with all the information required in Form 27. The fee for search and automatic 90 day reservation is \$20.00 payable at the time of requesting the search. You must be able to provide either a deposit account number or Visa or MasterCard number. The \$20.00 name search fee will not be payable where a federally incorporated corporation is registering.

Registration may be effected by sending to the Director:

- (a) Application for Registration (Form 22);
- (b) Power of Attorney (Form 24) appointing a resident of Saskatchewan to act as power of attorney;
- (c) Verified Articles of Incorporation;
- (d) Certificate of Status (also called Certificate of Good Standing or Certificate of Compliance) issued by the home jurisdiction. An original certificate is required;
- (e) Prescribed registration fee of \$100.00, the \$20.00 name search fee and \$15.00 Gazette publication fee; total fees \$135.00.

#### EFFECT OF REGISTRATION

The corporation is registered in Saskatchewan on the date shown in the Certificate of Registration issued by Corporations Branch. A corporation, while registered, is entitled to carry on its activities in Saskatchewan subject to any other laws applicable to persons or corporations.

### **PAYMENT FOR SERVICES**

All services provided by Corporations Branch may be paid for by:

- 1) Cash/cheque/money order;
- 2) Visa/MasterCard

For 1) Mail requests - include your cheque or money order or Visa/MasterCard number (including expiry date).

2) Telephone requests/Fax requests - include or be prepared to provide your Visa/MasterCard number (including expiry date).

If you will be using Visa or MasterCard to pay for your name search and/or registration, use the Client Payment Authorization Form below to authorize payment. This authorization will be destroyed once payment has been authorized.

Before you form your corporation, we must do a name search to make sure the name you have selected is not similar to any other registered name.

- **ITEM 1:** Type or print the name of the person (or firm) requesting the name search be done, along with a mailing address and telephone number you may be contacted at.
- There are 3 levels of name searches you may request: a Saskatchewan only search, a Saskatchewan plus search or a Canada-Wide search. Please check the appropriate box. Be sure to include the appropriate fee with this request.
- Type or print the name(s) you would like searched in your order of preference. Only the first available name will be searched unless you ask for all names listed on the form to be reserved.
  - **NOTE:** Every Non-profit corporation must have the word "INCORPORATED", "CORPORATION", "INC." or "CORP." as the last word in its name.
- **ITEM 4:** Describe the types of activities your organization will conduct. Please be as specific as possible.
- **ITEM 5:** Check the appropriate box.
- CAUTION: If you select a Canada-wide search, you will find out if a similar name or trademark has been registered anywhere in Canada. If you select a Saskatchewan plus search, you will find out if there is a similar federal corporation or trademark. If you don't select either of the above searches, you may find out later that the name you have selected is too similar to a federal corporation or is trademarked. This might result in your having to change the name of your corporation, which could be very expensive for you.
