Overview of the Position:

The Provincial Laboratory Branch of Saskatchewan Health is currently seeking a highly motivated Laboratory Technologist to work as part of a team in the Virology Section of the Provincial Laboratory. You will be required to process, prepare and perform a variety of clinical tests while adhering to protocols and safety guidelines. Duties include processing of clinical samples of inoculation into suitable host systems, doing media changes, blind passages, etc. of inoculated tissue cultures; performing direct immunofluorescent procedures on clinical samples; preparing of a variety of tissue culture cell lines, media and reagents; and the processing and testing of specimens for *Chlamydia trachomatis* and *Neisseria gonnorheae*.

- Laboratory techniques and basic procedures including equipment relevant to virology

- > Standard precautions and proper laboratory safety practices
- > Typically the knowledge and abilities required would be obtained by the completion of either MLT (and eligible to be licensed by SSMLT) or B.Sc. or BLT in a relevant science. A background in virology would be an asset.
