CLAUSE 1

I/We appoint and empower him/her to handle all matters pertaining to the racing of my/our horses in Saskatchewan. This clause also includes 2, 3 and 4 stated below.

CLAUSE 2

I/We appoint and empower him/her to claim horses on my/our behalf and to direct the transfer of the necessary funds to cover any such claim. This clause does not permit the buying or selling of horses on my/our behalf, other than by claiming.

CLAUSE 3

I/We appoint and empower him/her to ask for and receive from racing associations licensed by the *SASKATCHEWAN LIQUOR AND GAMING AUTHORITY* any purse to which I/we are entitled and to receive and endorse cheques made payable to me/us by any such racing association.

CLAUSE 4

I/We appoint and empower him/her to act on my/our behalf and sell my/our interests in any horses wholly or partly by me/us. He/She is further authorized to execute a bill of sale for these horses.
