Sessions - Number of registration steps created within report date range. Date range is matched against the latest registration step completion date for a session.

Pending - Number of registrations with a status of Pending, In Progress, or Deferred. Date range is matched against the step creation date.

Actioned - Number of registrations that are completed or in the case of WCB and CRA linked (OneStop cannot determine a complete or incomplete session within iReg or BRO, only whether a user has linked to the iReg or BRO site). Date range is matched against the step actioned date.

Deleted - Number of All deleted registration steps. Date range is matched against the step creation date.

Deleted After Starting - Number of registration steps deleted after a user has started that registration process. (This is to determine users giving up on registration process.). Date range is matched against the step creation date.

Total Actioned and Deleted - Total registration steps actioned and deleted.

WCB/CRA Duplicate Sessions - Number of sessions where the user accessed iReg/BRO more than once. (This is to determine users having to go to BRO or iReg more than once.). Date range is matched against the step actioned date.

Session Restart Total - Date range is matched against the latest registration step completion date for a session.

Average Actioned Registration Steps per Session - For counting steps the date range is matched against the step actioned date. For counting sessions the date range is matched against the latest registration step completion date for a session.

Sessions with E-mail Response Method - Date range is matched against the latest registration step completion date for a session.

Sessions with Fax Response Method - Date range is matched against the latest registration step completion date for a session.

Sessions with Mail Response Method - Date range is matched against the latest registration step completion date for a session
