C E A S E T R A D E O R D E R

WHEREAS on the 4th day of April, A.D., 1984 a Temporary Order was issued that trading in securities of Spanish River Hotel should cease forthwith for a period of 15 days from the date hereof, pursuant to Section 151 of The Securities Act;

AND WHEREAS satisfactory information was not provided to the Commission within the 15 day period stated in that order;

AND THEREFORE, the Commission being of the opinion that it is in the public interest that trading in securities of Spanish River Hotel should cease; It is hereby ordered that the Temporary Order of April 4, 1984 be extended until such time as satisfactory information is provided to the Commission.
