**EXTENDING ORDER
(Section 134)**


WHEREAS the Saskatchewan Securities Commission (the "Commission") issued a temporary cease trade order on the 15th day of August, 1991 (the "Temporary Order") pursuant to subsection 134(3) of The Securities Act, 1988, S.S. 1988, c.S-42.2 (the "Act") that trading in securities of Wall Street Venture Capital Ltd. (the "Issuer") cease up to and including the 30th day of August, 1991.

AND WHEREAS the Issuer being a reporting issuer other than a mutual fund within the meaning of the Act, has failed to file in a form acceptable to the Commission annual audited financial statements for the financial year ending April 30, 1990, as required under section 87(2)(b) of the Act and sections 117, 125 and 126 of The Securities Regulations, R.R.S., c. S-42.2 Reg 1 (the "Regulations").

AND WHEREAS the Commission has not been provided with sufficient information to enable it to make an order under subsection 134(1);

THE COMMISSION HEREBY ORDERS, pursuant to section 134(3) of the Act, that the Temporary Order be and is hereby extended until such time as the Issuer files in an acceptable form, annual audited financial statements for the financial year ending April 30, 1990 or until a hearing is held before the Commission at the request of the Issuer.
