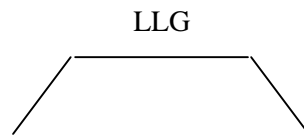
## Brand Application

### ***Purpose***

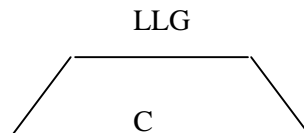
All cattle purchased by the association must be branded with a permanent, legible brand registered in the name of the Association. The *Brand Application* form (CF1) is a sample of the form used to register an association brand.

### ***Completion***

- 1) The *Brand Application* form (CF1) allows the association to apply for up to six choices of brand design and/or location.
  - The association may choose to use any or all of the six available brand locations.
  - In the event the brand choice is not available, the Inspection and Regulatory Management Branch will designate a brand if the association desires.
- 2) The brand for feeder heifers, steers, and breeder cattle must consist of a letter or number, or a combination of both, over a shelter, as outlined in the example below:



- 3) The brand for feeder cows must consist of a letter or number, or a combination of both, over a shelter over C.
