## **Livestock Manifest**

### ***Purpose***

The *Livestock Manifest* (form CF22) must always be used when selling association livestock.

### ***Policies and Procedures***

- 1) Cattle branded with the association's brand should be listed on a separate *Livestock Manifest* from privately owned cattle.
- 2) Where association and privately owned cattle are included on the same *Livestock Manifest*, the association must be listed as the payee (the owner of the cattle), with the member listed as the contributor.
- 3) For additional information about the *Livestock Manifest* and the process for selling association cattle, refer to page J-1.
