

HUNTER INFORMATION SHEET

2006 CHRONIC WASTING DISEASE MANAGEMENT PROGRAM

Herd Reduction Areas:

Herd Reduction Area 11 - in portions of Wildlife Management Zone 11 and the western part of Wildlife Management Zone 14W located along the Red Deer and South Saskatchewan River systems

Herd Reduction Area 14 - all of Wildlife Management Zones 12, 13E and 14E east of the Lancer Ferry and portions of Wildlife Management Zones 23 and 24 near Riverhurst

Herd Reduction Area 25 - portion of Wildlife Management Zone 25 east of Kindersley near D'Arcy

Herd Reduction Area 46 - portion of the Manitou Sand Hills

Herd Reduction Area 47 - portion of the Bronson Forest in Wildlife Management Zone 68S and an area northwest of St. Walburg in Wildlife Management Zone 47

Herd Reduction Area 50 - portions of Wildlife Management Zones 50 and 62 and Fort a la Corne Wildlife Management Unit including the area near the positive cases near of Love and north of Garrick

Maps of the Herd Reduction Area boundaries will be available at all permit distribution points.

Chronic Wasting Disease Control Permits (CWD):

- Chronic Wasting Disease Control Permits are available to Saskatchewan residents only
- in HRA11, HRA25, HRA14, HRA46 and HRA50 hunters will initially be issued one antlerless CWD permit and one 3 Point or Less CWD permit: when the hunter has harvested and submitted the heads from animals taken under these permits, he/she will then be eligible for an Either-sex CWD permit (this permit is valid for a doe, fawn or any size buck)
- in HRA 47 hunters will initially be issued two Antlerless CWD permits, when the hunter has harvested two antlerless deer and submitted the heads from these animals, he/she will then be eligible for an Either-sex CWD permit (this permit is valid for a doe, fawn or any size buck)
- this process can be repeated
- a hunter may be issued a maximum of two Either-sex CWD permits
- the deadline for sample submission is January 15, 2007

Season Dates:

Herd Reduction Area 11 – November 20 to December 16, 2006

Herd Reduction Area 14 – November 6 to December 16, 2006

Herd Reduction Area 25 – November 6 to December 16, 2006

Herd Reduction Area 46 - November 6 to December 16, 2006

Herd Reduction Area 47 – October 16 to December 16, 2006

Herd Reduction Area 50 – November 6 to December 16, 2006

Testing:

- adult deer heads will be accepted from anywhere in the province for CWD testing
- elk heads will only be accepted from hunters who hold draw licenses in Wildlife Management Zones 14, 42, 42A, 43, 43A, 50A and the Fort a la Corne Wildlife Management Unit
- deer fawns and elk calves will NOT be tested for Chronic Wasting Disease
- samples with incomplete information, in particular incomplete harvest location information will NOT be accepted or tested
- please refer to your sample tracking stub for the website address you may use to access head sample test results

Hunting Regulations:

- **in HRA11, HRA14 and HRA25 the holder of a CWD permit shall not, without the consent of the landowner or occupant, operate or be a passenger in any vehicle for hunting or for any purpose related to hunting, including retrieval of animals, except on a road or trail**
- all other regular hunting regulations apply to the use of a Chronic Wasting Disease Control Permit
- do not drive on crops, seeded, muddy or swathed fields
- report any hunters damaging crops or property
- close all gates
