TO: ALL VENDORS AND CONSUMERS

RE: THE EDUCATION AND HEALTH TAX ACT

As a result of the March 26, 1999 budget, the Education and Health Tax rate is reduced from 7% to 6% effective March 27, 1999. A tax schedule is attached to assist vendors in collecting the tax at the 6% rate. In addition, the tax rate on mobile homes, modular homes and ready-to-move homes is reduced from 3.5% to 3% effective March 27, 1999.

Please note that the Liquor Consumption Tax rate remains at 7%.

TRANSITIONAL RULES

The following guidelines apply to sales and purchases:

- Items delivered to customers on or after March 27, 1999 are subject to tax at 6%. This applies even if the item was ordered or fully or partially paid for before March 27, 1999.
- Items delivered to customers before March 27, 1999, but paid for on or after March 27, 1999, are subject to tax at 7%.
- The 6% rate applies to billings for telecommunication services, leases, non-residential electricity and the right to use packaged or pre-written computer software programs where the service is received on or after March 27, 1999.
- Taxable lodging provided on or after March 27, 1999 is subject to tax at 6%.
