IF UNDUE HARDSHIP CLAIMED- Both parties must file **THIRD PARTY** financial information of those residing in their household.

UNCONTESTED FAMILY LAW MATTERS:

The affidavit of Applicant(56A.24A) is only file when its for a DESK order. The affidavit has to be signed by the person applying for the order. Can't be signed by a LAWYER.

DIVORCE: DESK ORDER

SERVICE:

BELOW ARE THE APPLICATIONS THAT HAVE TO BE PERSONALLY SERVED;

- 6. Where personal service is required by law.

SERVICE - GENERAL:

- l. By leaving a copy with a lawyer who acknowledges acceptance of service in writing on document.
- 2. By mail to the person with an acknowledgment of Service SERVICE NOT VALID UNLESS FORM 56A.10C is returned and filed with the Court.
- 3. By leaving it at person's residence with adult person at residence and mail another copy of application at his/her residence AFFIDAVIT OF SERVICE REQUIRED.
- 4. Director CYFS only need to leave a copy with Director
- 5. Judge can approve other types of services
- 6. The best way is to do it by REGISTERED MAIL and get the slip from the Internet stating it was picked up.
